[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the service of a Horse Impressed into the Publick service at Orangeburg by order of Governor Rutledge in the year 1779 –

Samuel Nelson made oath that being in the publick service wagoning that the above horse was impressed out of his team at Orangeburg by order of Governor Rutledge on the 3<sup>rd</sup> day of May in the year 1779 and Immediately was put into the Artillery Service.

Robert Bond made oath that he Lay out of the aforesaid Horse his property from the time above mentioned till the 4<sup>th</sup> of June 1781 and that he spent much time in order to procure said horse but never could till by accident he found him in possession of a person unknown to him at the Siege of Ninety Six and that in consequence of his trouble and want of said horse he charges the sum of £80.20 So. [South Carolina] Curry [currency]
