I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." I also Impower my said Attorney to act in that Case as he shall think proper & to assign any Receipt that may be necessary Concerning the above premises as fully as if I myself were personally present. By virtue of these presents as witness my hand this 28 day of August 1785
