The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

South Carolina Lexington County} Personally appeared before me Alexander Blair Esquire one of the Justices appointed to keep the peace for the County aforesaid John Brooks who being duly Sworn on the holy Evangelist of Almighty God Saith on his oath that in the late War he supplied Colonel Hammond's [LeRoy Hammond's] Regiment with a Quantity of Pork supposed to be 5 or 600 pounds an Account of which he gave into John Fairchild Esquire to give in to the Officer appointed to receive Accounts and also that Served in the Militia Service 5 or 6 Months under Colonels Heatley [Charles Heatley] & Beams in different Tours for which he never Received any Compensation. Sworn this 3rd day of January 1791
