The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 2: Printed form of Indent No. 41+<sup>2</sup> Book F dated February 9, 1784 "delivered to Mr. Gasper Brownguard this our Indented Certificate for the Sum of Forty-five pounds two Shillings and two pence halfpenny Sterling, for his pay as a private Soldier in the South Carolina Continental Line from the 1<sup>st</sup> February 1780 to the 1<sup>st</sup> July 1783 (one year being deducted while he served in Colonel P. Horry's [Peter Horry's] Regiment of Light dragoons, and for which he received Colonel Horry's Certificates) per Account Audited &c...."]
