The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]



To the Honorable the Senate and House of Representatives of the State of South Carolina The Petition of James McCracken of the District of Horry and the State aforesaid, Respectfully Sheweth: That your petitioner was a soldier in the Revolutionary War, under General Marion [Francis Marion], that his immediate commanding officers were Captain Absalom Sessions, Captain Joseph Long, and frequently by Lieutenants, whose names in the lapse of time are forgotten by your petitioner, was in many engagements and skirmishes with the Enemy, at Edisto [River] at Parker's Ferry, 2 Santee³ – Black River⁴ and Elsewhere, that he also served under Marion, near Georgetown and Charleston, That he is now in the 70th year of his age & his memory defective as to dates, that age is now pressing hard upon him, that he is incapable of those exertions that belong only to Youth and vigor, and he therefore hopes, that your Honorable Bodies may take his case into consideration, and extend to him the same kind hand of relief that of those similarly situated have experienced. In the course of nature your Bounty (if granted) must in a few years cease to be, and in craving at your hands a Pension, he hopes (that as it bes [sic, is] in your power) your kindness will assist in smoothing his passage to the grave, and plucking from his breast the thorns of anxiety and care that are now troubling the remnant of a life whose energies and manhood have been used in making his Country free and Independent. - Should the prayer of Your Petitioner be granted, he will as in duty bound for ever pray &c
