Pension application of Joshua Younger W10009<sup>1</sup> Catharine Younger f110VA
Transcribed by Will Graves 7/18/11 rev'd 6/14/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Nicholas County State of Kentucky (Sct) June 22, 1818

This day Joshua Younger personally appeared before me John Trimble one of the Circuit Judges in and for the State of Kentucky and made oath that in January in the year of our Lord 1777 he enlisted as a private soldier for & during the war in the 2nd Virginia Regiment on Continental establishment or Continental Army commanded by Colonel James Wood and that he belonged to Captain William Vaus's [William Vause's] Company and to the Brigade commanded by General Scott and that he continued to serve in said Regiment and the Army until sometime in May 1779 at which time he was discharged on account of having received a wound in said service he states that his discharge has been lost by accident but that he has a Certificate from Colonel James Wood of his service in said Army a true copy of which Certificate is hereby certified by me and he states that from his reduced circumstances in life he needs the assistance of his Country for his support and he also states that he has at this day no other evidence of his enlistment and service in said Army within his power and that he has received no pension from the General government at any time a Certificate from Doctor John R Ward with the Counter Certificate of John Hopkins a justice of the peace is herewith sent.

Sworn to and declared before me the 22nd day of June 1818 S/ John Trimble

[p 12: On April 30th, 1838 in Lawrence County Indiana, the veteran filed for a transfer of his pension benefit to the Indiana agency saying he had recently moved there for the purpose of living with his children. The veteran signed this application with his mark.]

County of Nicholas Sct. State of Kentucky

On the 31st day of March 1828 personally appeared in Open Court (being a Court of record for the 2nd Judicial District in the County of Nicholas held in the town of Carlisle) Joshua Younger resident in said County aged 74 years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provisions made by the acts of Congress of the 18th of March 1818 and the first of May 1820. That the said Joshua Younger enlisted during the war in January in the year 1777 in the State of Virginia in the County commanded by Captain William Vaughs [William Vause's] in the Regiment commanded by

Colonel James Wood in the line of the State of Virginia on the Continental establishment that he continued to serve in the said Corps until sometime in May 1779 when he was discharged from the service in consequence of receiving a wound in the Town of Winchester in the State of Virginia. That he hereby relinquishes every claim whatever to a pension except the present: that his name is not on the pension roll of any State except the one transmitted which is on your files. And that the following all the reasons for not making earlier application for a pension, my first declaration was prepared by General Andrew S Hughes attorney at law, when they were returned he handed me the papers and told me that my claim was not allowed, and I being old and ignorant never made further application until the date of my 2nd declaration. My occupation is that of a farmer but unable to follow it. My wife was 62 years old last December. I have one son and his wife living with me, his name is Garret aged 22 years, his wife 20 years old, neither myself nor wife has been able to support ourselves by our labor for many years past, and I am much indebted Fort necessities to support him and what little property I now have will be sacrificed to pay my debts, and will not paid the one half of it. My property consist of one mare 28 years old \$5, nine head cattle \$35 one plow two pair of gear one ax \$9.50, three beds bedsteads and bedding \$36 household and kitchen furniture \$20, eleven head of sheep \$5.50, twelve shoats one sow \$8, total amount \$119.

And in pursuance of the Act of the first May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed that no particular change has taken place in my property since the 18th of March 1818 except the property which I sold to pay my lawful debts, which have been to a small amount signed S/ Joshua Younger, X his mark

Sworn to and declared on the 31st day of March 1829 before me S/ H. O. Brown, Judge

[p 19: On August 15, 1843 in Lawrence County Indiana, Catherine Younger, 74, filed for a widow's pension under the 1838 act stating that she is the widow of Joshua Younger, a pensioner of the United States for his service in the revolution; that she married him September 15, 1787; that her husband died August 2, 1834; and that she remains his widow. She signed her application with her mark.]

[p 21: On March 21, 1856 in Lawrence County Indiana, the widow (giving her age as 91 years) filed for her bounty land entitlement stating that her name prior to her marriage was Catherine Yoter. She signed this document with her mark.]

I hereby Certify that Joshua Younger a private in the late revolutionary war half agreeable to the loss of the United States been placed on the List of military pensioners for the state of Virginia at the rate of \$1.66 2/3 per month and that at the rate thereof he still standing on said list and is legally entitled to the benefit thereof.



The Bearer hereof Joshua Younger was a private in the 12th Virginia Regiment of Continental establishment until he received a wound which rendered him unfit for further service when he was regularly discharged by me a Colonel of the said Regiment after which he was placed on the List of pensioners. I further certify that he was esteemed a Good Soldier while in service and that he has from every information which I have been able to obtain maintained the Character of a respectable Citizen.

Given from under my hand at Richmond this 30<sup>th</sup> day of January 1807

I Abraham Hite<sup>2</sup> of Jefferson County Kentucky formally a Captain in the 12th Virginia Regiment on Continental Establishment do hereby Certify that Joshua Younger served as a soldier in Captain William Vauses Company in the aforesaid 12th Virginia Regiment and that from a record size roll &c the soldiers belonging to that Company and Regiment which is now in my possession the said Joshua Younger appears to have been enlisted on the 18th day of January 1777, During the War, born in the State of Virginia and is noted to be discharged but when and for what cause is not mentioned on the Record nor does my memory serve me to say either as to [indecipherable words] or for what cause he was discharged.

Given under my hand this first day of August 1819



I do with the advice of the hereby certify that Joshua Younger aged 34 years late a private in the 12 Virginia Regm: whose pay was at the rate of £24 p: Annum was disabled in the service of the U. S. by a hurt which [indecipherable word, looks like "occasionet" perhaps intended to be "occasioned"] a rupture and that he is allowed Six pounds p: annum to Commence from the first of January 1786

[Veteran was pensioned at the rate of \$8 per month commencing January 11, 1830 4 service as a private in the Virginia Continental line. Veteran's widow was initially pensioned at the rate of \$80 per annum which rate was increased to \$96 per annum effective July first, 1848.]

Joshua Younger appeared before me a Justice of the Peace for said County and made oath that he Enlisted in the year 1777 in Captain Vosses Company of the 12<sup>th</sup> Virginia Regiment on Continental line Commanded by Colonel Wood for during the War and that he continued in service until he was wounded in the Battle of Brandywine [September 11, 1777] and was honorably discharged at the Barracks in Winchester in the year \_\_\_ by Colonel Wood on account of his being disabled by said wound and that he has never received the Land bounty for said service

The within named James Fitchpartrick made oath before me a Justice of the Peace for said County that he Enlisted in the year 1777 in Captain Vosses' Company of the 12<sup>th</sup> Virginia Regiment commanded by Colonel wood for during the War and that he continued to serve in said Regiment until the close of the War in the year 1783 at which time he was honorably discharged and that through the course of time he has lost his discharge – and has never received his land bounty.
