[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]


Grant Knowlton personally appeared before me Langdon Cheves one of the Associate Judges of the said State, who being duly sworn made oath that some time about the month of July 1775 he entered a soldier under Captain Mason [William Mason] in the Second Regiment South Carolina Continental Troops, then commanded by Colonel William Moultrie -- That he served in said Regiment during the said year and until the year 1777 when he was regularly discharge by Colonel Isaac Moote [sic, Isaac Motte] who succeeded Moultrie in the command of said Regiment -- That he was stationed nearly the whole of that time in the vicinity of Charleston and was in Fort Moultrie at the time of the attack upon that Fort [June 28, 1776]<sup>1</sup> -- That after his discharge he joined Marion's [Francis Marion's] Brigade & during his service in said Brigade he lost the discharge which he received from Colonel Motte -- That he is 64 years of age & infirm, & obliged to support himself by his own personal labor & that he stands greatly in need of assistance from his Country.

[p 16: in a power of attorney dated October 31, 1853 filed in Sumter District South Carolina, John W. Knowlton stated that he was the only surviving child of Grant and Frances Knowlton.

[p 17: Josiah Ming testified October 11 1853 in Sumter District South Carolina that Grant Knowlton was a soldier in the regular Army from 1776 to the close of the war; that he married miss Frances Evans in 1789 and that he had three sons, William, Ephraim and John Withers; that William and Ephraim are dead leaving John W. Knowlton as the only surviving child; that Grant Knowlton died in 1820 and that Mrs. Frances Knowlton, never having remarried, died January 14 1844.]

[p 18: On October 11, 1853 in Sumter District South Carolina Mary Evans, aged 78, and John Herrington, aged 76, gave essentially the same affidavit except they refer to the surviving child as John Witherspoon Knowlton. They state that the veteran died in 1820 leaving Francis his widow; that Francis died January 14, 1844. Both signed with their respective marks.]

#### [p 19]

State of South Carolina Sumter District: Court of Ordinary in Session November term 1853

On this 12th day of November 1853 before the said Court now in Session personally came John W. Knowlton who being duly sworn according to law upon his oath makes the following declaration for the purpose of obtaining for himself the pension due to his mother Frances Knowlton deceased that her deceased under the acts of 7th of July 1838.

That he is the son of the said Frances Knowlton who was the widow of Grant Knowlton late of Sumter district South Carolina deceased. That his father the said Grant Knowlton was a Revolutionary Soldier during the whole war from the commencement to the termination thereof, as he has often heard his father relate the many battles he was in and being wounded in the knee, head and arm after he came to South Carolina at Camden where he was taken prisoner and released by the Surprise of General Marion and afterwards at Eutaw Springs and previous to come into Carolina was at Bunker's Hill, Saratoga, Flatbush and Brandywine under Colonel Morgan and General Gates; that he entered the Army at Boston and discharged in South Carolina: that his said father and mother were married in said district and State in the year 1789 and that his mother's maiden name was Frances Evans. He further states that his said father died on the 21st April 1820 [last digit written over and indecipherable] leaving the said Frances Knowlton his widow, who did not again marry, but remained his widow until the 14th day of January 1844 and she died leaving the declarant and a Brother William who is since dead; The declarant further says he believes it was under Colonel Williams his father fought at Camden and subsequently was under Captain Withers -- Captain Mayson and Captain Horry in General Marion and General Sumter's Brigades: That he further declares he was born on 3rd day of November 1800 being the youngest of many children of his father and Mother a number of whom died in infancy and were not christened: That his said father Grant Knowlton proved his Services in the Army by Isaac Kiells and John Keills two of his fellow Soldiers who are now

dead some 15 years ago and that his said father received a pension at the rate of eight dollars per month up to the date of his last draw before death in 1820 as before declared.

South Carolina Sumter District: Personally appeared before me the undersigned and deposeth on oath that he recollects distinctly that his father Grant Knowlton had a record kept in his family Bible of their marriage and births of all his children, but old age and hard usage, had made it go into oblivion just before it departure when I was a boy the Bible Society presented my father with a new Bible, he then took and set down correctly their marriage and births of his children, after the death of his father Grant Knowlton, his mother broke up housekeeping and lived amongst her relations and in going from place to place, that Bible is misplaced or lost but recollect well of setting down his father's marriage in 1789.

State of South Carolina Sumter District: Personally appeared before me one of the Justices assigned to keep the Peace, for said District, the undersigned and deposeth on oath, that he has been long and personally acquainted with the Grant Knowlton and his wife Francis Knowlton. He did not see them married in consequence of their having to go to a magistrate some 10 or 15 miles off across a large swamp. On their return back next day to the neighborhood, they lived as husband and wife in peace and quietness and the fear of God, from 1789, to his death in 1823, also deposeth that William Knowlton was born December 31, 1791 -- which had he been living would be now 63 years of age. He also deposeth that he was well acquainted with the record kept by Grant Knowlton in his family Bible which has long since been lost, the above is an accurate statement, as I am willing to testify this 7th day of January 1854

[Veteran was pensioned at the rate of \$8 per month commencing October 22<sup>nd</sup>, 1818, for service as a private for 2 years in the South Carolina Continental line. His widow's Ayers received a pension in a like amount by right of her having survived her husband and qualified for a pension which she never claimed for herself.]

To the Honorable the President & other Members of the Senate of South Carolina – The humble petition of Grant Knowlton of Salem County<sup>4</sup> Sheweth That your Petitioner in the year 1779 Enlisted in the service of this State in the regiment commanded by Col. Daniel Horry – that in defense of his Country's rights he was wounded near Camden in the Battle in which Gates [Horatio Gates] was defeated [Battle of Camden, August 15-16, 1780]<sup>5</sup> by Lord Cornwallis – one wound in the knee by a musket ball – Another in the arm by a Bayonet – That he afterwards served under Genl. Marion to the end of the War – that in consequence of the injury he received by the wounds aforesaid, he is unable to make a living as


