Pension application of Abram Richardson W13852 Winney Richardson f27SC Transcribed by Will Graves 11/26/09: rev'd 6/10/17 & 12/31/19

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina Edgefield District}

On this twentieth day of October in the year of our Lord 1837, personally appeared before the Court of General Sessions & Common Pleas for Edgefield district in the State aforesaid, Winney Richardson, a resident of the District and State aforesaid, aged eighty-four years, who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 4th 1836: That she is the widow of Abram Richardson who was a private in a Militia company of the State of South Carolina, raised under the authority of said State during the war of the Revolution between Great Britain and the United States, of which said company John Hammond was Captain, Nathanael Bacon 1st Lieutenant and William Covington 2nd Lieutenant at the time he the said Abram attached himself to the said company. That the said Abram Richardson enrolled himself in said company as a volunteer in the early part of February 1779, but it is impossible for this declarant to specify the precise day; that the said militia company of State Troops commanded by John Hammond as aforesaid, was attached to the Regiment of the State Troops commanded by Colonel Leroy Hammond of which Regiment John Purvis was Lieutenant Colonel and Hugh Middleton Major, and that said Regiment was attached to General Andrew Williamson's Brigade of State Militia, the said Brigade consisting of militia raised under the authority of the State aforesaid. That he was in that service at least five months, and that he rendered frequent other and valuable services -- that shortly before the siege of Augusta, said Abram Richardson joined [Lt.] Colonel Samuel Hammond's Regiment of State Troops as a volunteer, which said Regiment was enlisted for sixteen months, and was made by Colonel Samuel Hammond as Assistant Quarter Master and occasional Assistant to the Commissary Department, and that said Richardson served out the sixteen months. He was never enlisted, but as a volunteer continued in the service, until the close of the war. He was frequently employed in [indecipherable word or words, could be 'private'] and dangerous and confidential commissions. When the British were advancing against Green [sic, Nathanael Greene] who was lying in siege at Ninety Six [May 21-June 19, 1781], Colonel Samuel Hammond who was then at the head of his Regiment on Edisto sent Richardson with a note informing General Greene of the enemy's advancing. The message was delivered and upon Richardson's return Colonel Hammond having been compelled to retreat in the meantime, and having left a company to protect the country under the command of Captain Thomas Harvey, Richardson joined said Company, and was with that company in the battle of Rodgers Old Field, near Edgefield Court House. Immediately after

the expiration of the sixteen months Richardson attached himself to Colonel Samuel Hammond's Regiment and continued in it until he was discharged from the service which took place at Bacon's Bridge near Dorchester South Carolina at the close of the Revolutionary War.

The Claimant further declares that she has no documentary evidence in support of the claim -- she further declares that she was married to the said Abram Richardson on the 5th day of April 1775, that her husband the aforesaid Abram Richardson died on the 14th day of July 1817, and that she has remained a widow ever since that period -- as will more fully appear by the proof hereto annexed.

State of South Carolina Edgefield District:

Personally appeared before me George Pope, Clerk of the Court of Common Pleas & General Sessions for the District & State aforesaid, and ex officio Justice of the Quorum for the District & State aforesaid, Samuel Hammond, who being first sworn in due form of law, deposeth as follows that the services rendered by the said Abram Richardson in the war of the Revolution, as stated in the prefixed declaration, are strictly and accurately true, that he the said Samuel Hammond held the commission of Colonel during a portion of the said war, and that the said Abram Richardson did render his said services in the said declaration stated, falls within his own personal knowledge, the militia company to which the said Abram Richardson was attached, composing at one period a part of the Regiment of the militia of the State of South Carolina, of which he was in command. This deponent further states that the said Winney Richardson is as she declares, the widow of the said Abram Richardson, and that she was married to the said Abram at least as early as the year 1779.

Richardson (this deponent) is the only & sole heir at law (surviving) of the said Winney Richardson deceased.

[Veteran's widow was initially pensioned at the rate of \$146.67 per annum commencing March 4, 1831, for service as Quarter master for 10 months and as a private for 14 months, all in the South Carolina militia. She was later pensioned at the rate of \$253.33 per annum commencing March 4, 1831 and ending on her death on October 31, 1843. The amount of her pension was based on her husband's service for 16 months as Quarter master and for 8 months as a private in the cavalry, all in the South Carolina militia.]
