State of North Carolina Moore County: SS

On this 27th of January 1846 Personally appeared in open Court Richard Warner a resident of said County aged fifty-six and being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefits of the provision made by the act of Congress passed the 4th of July 1836. That he is the son of Elizabeth Warner who was the widow of Hardin Warner -- who was a soldier in the Revolutionary war in the Continental line of North Carolina. That his said Father enlisted for the term of the war and served three years and six months and Colonel Sheppard's Regiment under Captain Blount as he heard him say the number of the Regiment he does not recollect and that not long after the close of the war he sold his Bounty land to one Philip Hodge as he told him many times -- And he further saith that his said Father and Mother was married in Greene County North Carolina and that his said Father Hardin Warner died in the month of April 1833 (and was at the time of his death about seventy-five years old) -- and that his said Mother Elizabeth Warner remained a widow from the time of his Father's death as above -- up to the day of her death which occurred on 26th day of November 1842 -- and that she left surviving her five children namely -- Wincy Warner the oldest child, who married William Sears,-- Polly Warner who married Holden Cox -- Nancy Warner who married Thomas Grayham, myself Richard Warner and Hardin Warner Junior -- and he further saith that his Mother's maiden name was Elizabeth Turnage and that at her death she was about eighty years old -- and he further saith that he has no family Bible or other evidence of the marriage of his said Father and Mother but well remembers to have heard them say they were married before the last period of his service in the war and that they had one child born before the close of the war and he further saith that his said Father and Mother had 3 children older than myself and that there was 2 years and a half between the births of each child -- and he further saith that he supposes the reason his said Mother never made application for a pension was she did not know she was entitled as he never heard her speak of applying and that he himself did not know until recently that the heirs of a soldier was entitled to a pension and that when he ascertained fact he has made application for what was due his Mother at the time of her death for the services of his deceased Father Hardin Warner and he does now for himself Brother & Sisters relinquish all claim to a pension except the present. State of North Carolina Moore County

This day personally appeared before the Subscriber a Justice of the peace in and for said County Wincy Sears a resident of said County aged sixty-five years and being first duly sworn according to law deposeth as follows that she is the daughter of Elizabeth Warner who was the widow of Hardin Warner deceased who was a soldier in the Revolutionary war in the Regular service as he told her -- and that he sold his Bounty land to one Philip Hodge of Cumberland County North Carolina -- and she further saith that her said Father Hardin Warner was about making an application for a pension before his death and that Mr. Cornelius Dowd was his agent in fixing up his papers -- and that before his papers were ready to send to the War Department her said Father died and she further saith that she has often heard her said Mother talk of the great hardships and inconveniences she suffered while her said Father was in the service and she further saith that she has often heard her said Father and Mother say that she herself was born while he her said Father was in the service of the United States in the war of the Revolution -- and she further saith that there is no family Bible or other record of the marriage of her said Father and Mother or the ages of the children -- but that she was always told by her Father and Mother that she was born in the year 1781. -- And further this deponent saith not. Sworn to and subscribed before made this 29th January 1846

State of North Carolina, Office of Secretary of State

I, William Hill, Secretary of State, in and for the State of North Carolina, do hereby certify, that it appears from the muster-rolls of the Continental line of this State, in the revolutionary War, that Hardin Warner a private Soldier in Captain Blount's Company of the 10th Regiment, entered the service on the 1st day of October 1779 for the term of the war. A warrant for bounty land was issued for the services of Harden Warner for 3 years & 6 months, drawn by Phill Hodge 13 November 1795 No. 3885.

[Veteran was pensioned at the rate of \$80 per annum commencing March 4th, 1831 and ending April one, 1833 when he died. He was credited with serving 2 years as a private during the revolution.]
