## Pension application of Archibald Wright W18460 Mary f50VA Transcribed by Will Graves 10/17/11

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

## State of Virginia, Charlotte County, to wit

On this 8th day of April 1847 personally appeared before me a Justice of the peace in and for the County and State aforesaid Sarah Moore the only surviving child and daughter of Mary Wright deceased (who was the widow of Archibald Wright, deceased) aged 62 years who being first duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 7th 1838 entitled "An act granting half pay and pensions to certain widows."

She declares, that she is the only surviving daughter and child of Mary Wright, deceased, late of the County of Cumberland and State of Virginia, who was the widow of Archibald Wright, a private soldier in Captain John Morton's Company, attached to the 4th Virginia Regiment on Continental establishment, in the War of the Revolution. That her mother the said Mary Wright departed this life on the 11th day of January, 1840.

She further declares that she knows nothing personally in relation to the services of her late Father Archibald Wright, but she has always understood from soldiers that he was in the service and served a long period of time. She therefore relies mainly on the Public Records of the Army, the Roll of Captain John Morton particularly, where his name will appear, and the accompanying Certificates of competence and credible witnesses, for proof of his service and the length of time, he was in actual service. She has understood that he enlisted for two years, and feels no doubt he served the full time with honor and credit to himself and Country. He was also, in the militia service –

She further declares that she always understood from her mother that she married her Father Archibald Wright in Cumberland County on or about the \_\_ day of \_\_ 1782; that her father Archibald Wright died on or about the 10th of June, 1810; that she was not married to him prior to his leaving the service, but the marriage took place previous to the first day of January 1794: to wit, about the time above stated – That her mother said Mary Wright, after the death of her husband Archibald Wright, never intermarried but remained a widow to the day of her death.

She further declares that the foregoing Declaration is now made and presented for the purpose of receiving the amount of Pension which her mother would have been entitled to up to her death had she been able to have prosecuted, and eventually succeeded, in the recovery of the same. She the said Sarah Moore being the only surviving child of said Mary Wright – That she is old, poor and infirm, and without a Horse, so that she cannot attend Court – to make this Declaration.

[f 11: On August 23, 1847 in Appomattox County Virginia, James McDearman, a preacher, gave testimony that at the special request of Mrs. Mary Wright he preached a sermon on August 8, 1839, Mrs. Wright's birthday; that he also preached at her funeral at the house of Mr. Peter LeGrand in Prince Edward County Virginia; that he knew Mrs. Wright for the last 36 years of her life; that he understood she was the widow of Archibald Wright; that she had two children Mr. Archibald Wright and Sarah Wright, wife of William I. Moore; that the son Archibald Wright has been dead many years.]
