[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Franklin County SS

On this 13<sup>th</sup> day of December A.D. 1841 personally appeared before me Joseph J. Williams one of the acting Magistrates in & for the County & State aforesaid, & a member of the Court of Pleas & Quarter Sessions, for said County (it being a Court of Record), Elizabeth Underwood, a resident of the said County of Franklin & State aforesaid, aged Eighty-One years, who, being first duly sworn according to Law, doth, on her Oath, make the following declaration, in order to obtain the benefit of the provision made by the act of Congress passed July 4<sup>th</sup> 1836: That she is the widow of Howell Underwood, who was a private in the Militia of North Carolina, in the Revolutionary War, and, served as such for the period of Twelve months, under Captain Joel Wren, Captain John White, Col. Benjamin Sewell [Benjamin Seawell]& the other officers.

She further declared that she was married to the said Howell Underwood on the 20<sup>th</sup> day of December 1777. That her husband, the aforesaid Howell Underwood died on the 1<sup>st</sup> day of June 1831, and that she has remained a widow ever since that period, as will more fully appear by reference to the proof hereunto annexed.

John King<sup>1</sup> an old Revolutionary Soldier maketh Oath that he has always understood that Howell Underwood was a Militia Soldier, but that he does not know it of his own personal knowledge but he says on Oath, that, Elizabeth Willis was married to said Underwood, about the year 1777 -- & that they lived together as Husband & Wife until the said Howell's death which was about 10 years past & that his widow Elizabeth is now a widow & has never married since her said husband Howel Underwood died.

months in the Revolution, under Captain Joel Wren, Commencing the 11<sup>th</sup> day of May 1781 – I also Certify that Elizabeth Underwood is the Widow of said Howell Underwood & that said Howell is dead & has been dead about 10 years last past & that the said Elizabeth is now a widow & has never married since her said Husband Howell died. Given under my hand & Seal S/ James Durham<sup>2</sup> this 10<sup>th</sup> day of March 1842.

I Certify that I know that Howell Underwood did serve as a Soldier of the Revolution for the term of six months, he served with me from February 1781 – for three months & also served with me for three months more in the year 1781 – under Captain Jordan Harris & Captain \_\_\_ Turner [Nathan Turner] – I know the widow of said Howell & that she is now living & has not married since her husband Howell died.

The said Howell Underwood was with me at the Battle of Guilford C. H. [Guilford Court House, March 15, 1781], N. C.

I Francis Riggan aged 78 Years, Certify on Oath that I was well acquainted with Howell Underwood, and that he served six months as a Private in the N. C. militia. That the said Underwood on the 10<sup>th</sup> day of February 1781 was drafted in Captain Jordan Harris's Company & served for three months ending the 10<sup>th</sup> day of May 1781. -- Afterwards to wit in the latter part of July 1781, the said Howell Underwood was again drafted for three months in Captain Turner's company & served out the same.

I know of the six months service of said Howell Underwood because he was with & served with me the whole time.

I also certify that Howell Underwood married Elizabeth Willis before he went in the Army & I know that Howell is dead & that his widow has never married since.
