
Be it remembered that the undersigned Archibald Young, this day appeared before me Alfred M Harris one of the circuit Judges in & for the State of Tennessee and being solemnly sworn deposeth & saith, that he did on the 15th of March 1776, in the county of Pittsylvania & State of Virginia, enlist as a private soldier in a company commanded by Thomas Hutchings¹, in the Sixth Regiment of Virginia troops on the continental establishment and did serve pursuant to said enlistment during the revolutionary war against the common enemy Great Britain on the continental establishment as aforesaid for the said term of two years, when he was honorably discharged. But he has lost the same through time or accident. He is a citizen of the United States and resident in the county of Giles & State of Tennessee. His pay warrant was in depreciated money and was in fact of little or no service to him. He is now in the seventy fourth year of his age as he believes he is quite poor & infirm He stands in need of assistance of his country for a support. He hath never received a pension from the United States.

He hereby relinquishes his claim to every pension granted him by the laws of United States previous to the passage of an Act of Congress thereof entitled as Act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war passed both houses of Congress on the 9^{th} March 1818 and signed by the President on the 21^{st} of the same month. He prays to be placed on the pension Act agreeably to the provisions of said act -31^{st} August 1818.

This day personally appeared before me Thomas Stuart Judge of the 6th Judicial Circuit of the State of Tennessee Thomas H. Perkins⁴ who is to me well known and who is a man of undoubted credit and respectability, and made oath that during the revolutionary war he himself was an ensign in a company commanded by Capt Thomas Hutchings in the sixth regiment of the Virginia Line upon continental establishment which regiment was commanded by Col. Buckner whose first name he does not remember. That he well remembers the above name as Archibald Young now in his presence and view to have been a private soldier in said company. This deponent commanded in said company for two years and a little more and he believes, and his understanding was that all the soldiers of said company were enlisted as soldiers for two years. That said Archibald Young was an orderly soldier as far as he knows or believes. He was an ensign in said company on the day of the Declaration of independence and afterwards was a lieutenant he has seen said Young many years ago several times since both left the Army in Pittsylvania County Virginia where said company was made up⁵ but has not seen him for many years until a few days ago. he knows nothing of his circumstances and further this deponent saith not.

Declaration in Order to Obtain the benefit Of the Act of Congress passed June 7th. 1832

On this twentieth day of August 1832 Personally appeared in Open Court before Alexr. Black, Robert Obrien & Archd. McKepack Justices Esqrs. & now sitting Archibald Young a resident of said County, who being first duly sworn according to Law, doth make the following declaration. That on the 26th day of November 1819 he was placed on the Pension List Roll of the West, at \$8.00 pr. Month as will be seen by his certificate hereto annexed, that under said certificate he drew two years pay & was then dropped struck from the Roll same, in consequence of having a little more property than was allowed to be held by him as a pensioner. He further states that he was a Private in the sixth Virginia Regiment of Regulars, that his present place of residence is in Giles County Tennessee & that he resided in the same place

when he made his first application. He also states that he made application under the Law of Congress 15th. May 1828, but that he never recd. a return, & draws no pension whatever.

In the matter of the application of Sarah Young for the benefit of the Pension Laws as the widow of Archibald Young decd., a Revolutionary Pensioner of the United States

Be it remembered on the 4th day of July AD 1849, at her own house in the County of Giles State of Tennessee, before Mr. B.F. Richey, a Justice of the Peace of said County, personally appeared Sarah Young aged about eighty nine years with whom I am personally acquainted, who having been duly sworn upon the Holy Evangelist according to law, declares, in order to obtain the benefit of the provisions of the Acts of 1836 & 1838 & any other Act of Congress applicable to her case.

That she was born about the year AD 1760, and was married when eighteen years of age to Archibald Young, in the County of Mecklenburgh [sic: Mecklenburg], State of North Carolina, at her fathers house near Hopewell Meeting House, by one John McKnight, a Justice of the Peace of said County. She thinks that sometime in the month of July AD 1778, and after her marriage, her husband Archibald Young served as a Revolutionary Soldier about two years & six months, during which time her husband sent her fifty dollars by hands of Col. Washington⁶, to bear her expenses to Pittsylvania County Virginia, whither she went at the time the British was in North Carolina.

After the war she lived with her husband in Pittsylvania County Virginia, until about the year 1810 when they removed to Middle Tennessee, and settled permanently in Giles County, State of Tennessee, where her late husband lived until the 12th day of November AD 1834, when he departed this life, being at the time of his death a Pensioner of the United States on the Revolutionary Roll, at the rate of ______ dollars per annum.

She further declares that she has no family record of birth or of marriage or of her husband, now in existence, nor is she able to find any, either in the records of the County Court of Mecklenburgh [sic: Mecklenburg], at Charlotte, nor in the church records of Hopewell Meeting House, in North Carolina, nor does she know of any living witnesses by which she can prove her marriage, unless here brother Joseph Powell, of Pittsylvania County, Virginia, or here husbands brother Wilie Young, of

Anderson County, State of Tennessee, be yet living. If either of them be living, she is satisfied that the time of her marriage can be proved, for she believes that both of them were present at the celebration of the rites.

One or both of them may have family records in relation to this matter, but she has not heard from them for a long time.

She further declares that she is still a widow, never having remarried since her husband Archibald Young's death.

Affiant further states that he has a copy his Fathers Family record & that he Wily Young was borned in the year 1772 & that his brother Archibald Young was borned about the year 1757. & that he was a soldier in the revolutionary war & that he removed with his family about thirty five years ago to Giles County State of Tennessee wheare he lived untill about the year AD 1837 wheare he departed this life being at the time of his death a pensioner on the Revolutionary Roll of the United States & wheare his widow the said Sarah Young still lives aged between eighty five & ninety years old.



Additional facts in file:

[76] Archibald Young of Giles County, Tennessee, who was private in the regiment commanded by Colonel Buckner of the Virginia line for a term of two years inscribed on the roll of West Tennessee at the rate of 8 dollars per month to commence on the 31st day of August 1818.

- [2] Archibald Young of Giles County, Tennessee who was private in the regiment commanded by Col. Buckner in the Virginia line for 2 years from 1776, was placed on the pension roll of West Tennessee at the rate of \$80.00 per annum to commence the 4th day of March 1831.
- [3] On 14 Jan 1850, Sarah Young, widow of Archibald Young who served in revolutionary War as a private for two years, was placed on the pension roll at the rate of \$80.00 per annum to commence the 4^{th} day of March 1848.
- [8] Widow Sarah Young died died 28 Jan 1850, leaving two children, Francis Smith and Sarah Meadows.

These are the only rolls on which Archibald Young appears, and as a musician, not a private. There is nothing to suggest he returned before the general discharge of the soldiers of the company in March 1778. He does report that he was honorably discharged and received a pay voucher but no other record corroborating these statements has been found.

In the same company was Haley or Healy Young, who appears only on the same two rolls as Archibald Young, and on the 31 May 1777 muster roll, is also noted as having deserted 1 May 1777. Pittsylvania County was responsible for one company of minutemen, under Captain Thomas Hutchings and Lt. James Conway (James Conway R13351 http://revwarapps.org/r13351.pdf), which was attached to the 6th Virginia Regiment. The company first marched to Gwynn's Island, where Lord Dunmore was camped. There are two deserter notices in Purdie's Virginia Gazette from this period.
