Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina District of Orangeburg: On this 29th day of November in the year of our Lord 1852 personally appeared in open Court now sitting before the undersigned a Judge of the Court of Ordinary which is a Court of Record, Charles R. Thomson a resident of Orangeburg District in the State of South Carolina aged 58 years who being first duly sworn according to law

doth on his oath make the following Declaration in order to obtain the benefit of the provision made by the act of Congress passed July 4, 1836: That he is the son & heir at law of Mrs. Elizabeth Thomson deceased who was the widow of Lieutenant Colonel William Russell Thomson who entered the service of the United States in the War of the Revolution under the following named Officers and served as herein stated: That before and during and after the Revolutionary War said Lieutenant Colonel William Russell Thomson lived in what is now Orangeburg District South Carolina and his father Colonel William Thomson having been appointed Colonel of the 3rd South Carolina Continental Regiment commonly called the Regiment of Rangers, by the Provincial or Continental Congress and continued to serve as such till about the year 1780 or '81, when the said Regiment was disbanded: That said Regiment was at the battle on Sullivan's Island and at Ninety Six Fort in this State and at the battle of Savannah in 1779 and in all of which it is likely this deponent's father said Lieutenant William Russell Thomson anticipated: That after said Regiment was disbanded said William Russell Thomson entered the militia service and South Carolina and served as private in the year 1781 in which capacity he served over one month and was promoted to the grade of Brigade Major and served as such one month and in the year 1782 he was appointed Lieutenant Colonel Commandant in which capacity he served 5 months: This militia service was part in General Sumter's & part in General Henderson's Brigade of Militia: That in the year 1783 and on the 25th of February of said year he married declarant's said mother: That prior to said marriage & subsequent thereto, said Lieutenant Colonel William Russell Thomson was in command as such Colonel for the period of 6 months terminating at the 19th day of April 1783: That this last service was in the Brigade of Militia commanded by General William Henderson: That Jacob Rumph commanded a company as Captain under said Colonel Thomson in this last mentioned service: That all of the service, rendered as above detailed, by deponents said father was in the Infantry and that this deponent is thus certainly & clearly entitled to state the facts of his said father services from old army papers now in possession of his family. He further declares that his said mother was married to the said Lieutenant Colonel William Russell Thomson on the 25th day of February 1783 of which fact the family is in possession of a family Record, and that the said husband the aforesaid Lieutenant Colonel William Russell Thomson died on the 7th day of April 1807, and that said mother remained a widow until her death on the 8th day of November 1838, in Orangeburg District South Carolina. That she never made application for her pension as such widow to which she was not aware of her right nor have her heirs been until of late. Sworn to and subscribed on the day and year aforesaid and above written Before me S/S. Glover, Ordinary O. D.

And I the said Judge of the Court of Ordinary do hereby certify that declarant above Charles R. Thomson is a gentleman of intelligence & high character and one to whose statements as above are due full faith and credit: it has this day been satisfactorily proven to me that said Mrs. Elizabeth Thomson who was the widow of Lieutenant Colonel William Russell Thomson of the Revolution died on the 8th day of November 1838 and that her only living children are Charles R. Thomson above named, Mary E. Darby, Charlotte Goodwyn and Caroline S. Lewis.

In testimony whereof I have hereunto set my hand and affixed my seal of office on this 29th day of November in the year of our Lord 1852.

State of South Carolina Orangeburg District: Personally appeared before me an acting Magistrate in and for said District Charles R. Thomson who being duly sworn says that the "Pay Bill" of Captain Jacob Rumph's company in Orangeburg District hereunto attached was found among the old papers of his father the late Colonel William Russell Thomson relative to the Revolutionary Services rendered by said father who was an Officer in the war of the Revolution: that Captain Jacob runs lived in this District until his death about 40 years ago: That this deponent refers to his declaration lately made as heir at law of his mother Elizabeth Thomson deceased for a more full & particular account of his said father, said Colonel William Russell Thomson's services in said war. Sworn to and subscribed before me this 28th day of February 1853

[In *The History of Orangeburg County, South Carolina* by A. S. Salley, Jr (1898) the following appears:

"Below is a roll of Capt Rumph's company. It was first published in the Clayton, Alabama, Banner, and had, it is said, been furnished that paper by the holder of the original roll. A copy of the published roll was sent to the Southron, a newspaper published in Orangeburg about 1860, by the late Capt A. Govan Salley, and it was republished in the Southron on September 10, 1861, with the remark that the editor had "no doubt of its authenticity", and that it was "worthy of remark that after the lapse of three-quarters of a century, the names, with scarcely an exception, still exist among the present inhabitants of Orangeburg District." The writer then adds: "The following are the names of Capt Jacob Rumph's men who fought the Tories of South Carolina in 1783, Orangeburg District, commanded by Col Wm Russell Thomson."

The writer was wrong in giving the date 1783, and he also probably mixed Wm. Russell Thomson up with Wm. Thomson, his father.


