Vs Application for a Pension

The United States

now on this day came the said Theophilus Weeks, in his own proper person and made the following

Original Claim

Declaration in order to be placed on the pension List under the Act of the 18th March 1818. County of Alachua [Florida]: SS

On this 20th day of April in the year of our Lord 1830 appeared in open Court being a Court of record for the district of East Florida, Theophilus Weeks, resident in said County, aged 69 years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the pension made by the Acts of Congress of the 18th March 1818 and the 1st of May 1820, that he the said Theophilus Weeks enlisted for the term of two and one half years on or about the 20th day of May in the year of our Lord 1776 as well as this deponent can now recollect but having lost all his papers connected with this case, he cannot state with certainty the time of his said enlistment or of his discharge, in the State of North Carolina, in the company commanded by Captain George Mitchell in the Regiment commanded by Colonel Lytle (or Colonel Taylor one of whom was Colonel the other Lieutenant Colonel but this deponent cannot now say with certainty which commanded at the time of his enlistment as aforesaid in the line of the State of North Carolina on the Continental establishment, that he continued to serve in the said Corps about one year when he was transferred to the company commanded by Captain Griffin John McCraea [sic, Griffith John McRae or McRee] in the Regiment commanded by Colonel John Clarke & that he continued to serve in the late mentioned corps until about the 20th day of November in the year of our Lord 1778, that of the exact time he cannot be certain, for the reasons aforesaid, when he was honorably discharged from the service in the state of New York (the period of his said enlistment having expired) and that he hereby relinquishes every claim whatever to a pension except the present, that his name is not on the roll of any State except

North Carolina and that the following all the reasons for not making earlier application for a pension, to wit that he had been informed and believed that he could not obtain a pension without making oath that he could not support himself without a pension and that he was not willing to make such oath, and in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed that since the 18th of March 1818, the following changes have been made in my property (to wit) I have lost two horses by death, and have sold a tract of land which I owned in the State of Georgia, for the sum of \$100 which sum has been expanded, in the necessary support of my family, the members of which now residing with me are my wife aged about sixty-eight years, who is quite feeble, a granddaughter eleven years of age a son aged twenty-five years a farmer by profession, who supports himself by his own labor having no property except a horse and 5 cows & calves, besides these I have living with me one Negro woman a slave, who however does not belong to me. I am by trade a Cooper but am unable to do much work = Signed

Sworn to and declared on this 20th day of April 1831 in open Court Schedule above referred to (viz.)

20 head of hogs 4 iron pots one oven one tea kettle 5 chairs 2 tables one old chest one old cart and a set of Coopers tools. Signed

[fn p. 262] Theophilus Weeks was born October 21st 1760 Ann Weeks was born October 25th 1763 Theophilus Weeks died July 21st 1839

[fn p. 172: on April 18, 1844 in Columbia County, territory of Florida, Ann Weeks, 80, filed for a widow's pension under the 1838 act stating that she is the widow of Theophilus Weeks, a pensioner of the United States for his services in the revolution; that her husband died on July 20, 1839; that she married him on \_\_ day of \_\_ in the year 17\_\_; that she did not marry him prior to his leaving the service but married him prior to January one, 1794.]

[fn p. 307: on April 18, 1844 in Columbia County, Territory of Florida, Mrs. Hester Weeks, testified that she is the sister of Ann Weeks, the widow of Theophilus Weeks, late a pensioner of the United States for his services in the revolution; that her sister and Theophilus Weeks were married in North Carolina before the end of the Revolutionary war; "That the record read to her from an old Bible of the births of the children of the said Ann and Theophilus, beginning with Mary and ending with John, is a true list of the children and in their succession, and that the first child, Mary, was born in less than a years time after marriage, that deponent does not read writing."]

[fn p. 323: on April 22, 1844 in Columbia County Florida, Ezekiel Weeks testified "that the record of the births of the children of Ann and Theophilus Weeks the latter now deceased and late a pensioner of the Army of the revolution (and the said record hereto annexed) is in the hand writing of James Brooks and was written by him; & that it has been (the said record) in the possession of the said Ann Weeks for 30 years last past."]

[fn p. 220: on April 18, 1844 in Columbia County, Territory of Florida, Ada Osteen testified that she is the sister of Theophilus Weeks deceased late a revolutionary Pensioner of the United States; that he married Ann Osteen before the close of the Revolutionary War; that the marriage took place in North Carolina; "that the record read to her from an old Bible (& which is hereto annexed) of the births of the children of said Theophilus and Ann, beginning with Mary Ann Indian with John, is a true and perfect list of the children and given in their succession, and that the first child, Mary, was born in less than a years time after marriage."]

[Veteran was pensioned at the rate of \$8 per month commencing February 18, 1831 for 2 years 6 months service in the North Carolina Continental line as a private during the revolution.]
