[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undecipherad' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

On this nineteenth day of December 1849 personally appeared before me George W Leigh one of the acting justices of the peace in and for the County and State aforesaid Mary Stubblefield a resident of said County and State aforesaid, aged Seventy Six years: who being duly sworn according to law, doth on her oath make the following declaration in order to obtain the benefit of the provisions made by the Act of Congress passed July 29th, 1848: That she is the widow of Beverly Stubblefield who was a Captain in the Continental Line of the State of Virginia and served in said line, in this Service of the United States from the 10th of January 1776 to the __day of January 1783; and also for 9 months Service more, as a Captain in said Continental Line in the War the Revolution in the Regiment called the commanded by Colonels __ Parker (as she believes) as will more fully appear from the Army Roll of the State of Virginia hereto annexed –

She further declares that she was married to the said Beverly Stubblefield on the 13th day of December 1796.

That she was not married to him prior to his leaving the Service; but the marriage took place previous to the 2nd day of January 1800 at the time above stated. She further swears that she is now a widow, and that she has never before made application for a pension. Sworn to and subscribed before me on the day and year above written. S/G. W. Leigh, JP

This is to certify, that it appears from a list in this office of such Officers and Soldiers of the Virginia __ Line as settled their accounts and received certificates for the balance of their full pay, according to an act of assembly, passed the November session 1781, directing the Auditors of Public Accounts to settle and adjust the pay and accounts of said Officers and Soldiers from the 1st January 1777 to 31st December 1781, (see Hening's Statutes at Large, vol. 10, p. 462,) that a settlement was made on the 26th day of June, 1783 in the name of Beverly Stubblefield as Captain of Infantry and evidence of the indebtedness of the State to him was £179.17.11, delivered to himself and was given, as appears by a copy of the settlement on file in this office, for services from the 1st January 1777 to 16th of June 1781 as Lieutenant and as Captain from 17th of June 1781 to 31st December following –
