Pension application of Lewis Davis Yancey (Yancy) <sup>1</sup> W2508 Phebe (Pheby) Yancey f48VA Transcribed by Will Graves 7/13/11 rev'd 7/22/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Georgia, County of Jasper: SS: Jasper Court of Ordinary - January Term 1833.

On this Seventh day of January 1833, personally appeared in open court before the Judges of the court of ordinary Lewis Yancey a resident of Jasper County and State of Georgia, aged Seventy one years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th 1832. That he was enlisted in the army of the United States in the year 1778 with Robert Yancy [Robert Yancey]<sup>2</sup> and served in the first regiment of the Continental line under the following named officers: Col Bland [Theodorick Bland] commanded the regiment of light Dragoons; John Jimison commanded as Major & Robert Yancy commanded the company and Latin Yancy [Layton Yancey]<sup>3</sup> commanded as Ensign; that he left the service the 24th day of December 1781, serving a tour of three years the whole length of time which he enlisted for. That at the time he entered the service he resided in Culpepper County [Culpeper County], in the State of Virginia. That he was engaged in the battle of Guilford [March 15, 1781] in the State of North Carolina and the battle of the siege of Savannah<sup>4</sup> in the State of Georgia; that he marched through the States of North and South Carolina and Georgia.

He hereby relinquishes any claim whatever to a pension or annuity except the present, and he declares that his name is not on the pension rolls of any agency in any state.

State of Georgia, County of Jasper.

On this the 7th day of September one thousand eight hundred & fifty three, personally appeared before me, a justice of the inferior court within and for the state and county aforesaid Pheby Yancy, a resident of the county of Jasper in the State of Georgia aged fifty eight years who first being duly sworn according to law, doth on her oath, make the following declaration in order to obtain the benefits of the provisions made by the act of Congress passed on the 3rd of February 1853, granting pensions to widows of persons who served during the revolutionary War; that she is the widow of Lewis Yancy who was a private in the Army of the Revolution that she is unable to state the nature of the service, that the said Lewis Yancy was a pensioner in his lifetime under the act of Congress passed the 7th day of June 1832, and paid at the agency of Savannah in the state aforesaid. The time when the deceased Lewis Yancy entered and left the service, the name and rank of the officers under whom the service was performed and the place in which he resided when he entered the service. She asks a reference to the evidence filed in his application. She further declares that she was married to the said Lewis Yancy on the 27th day of June 1820; that her said husband died on the 6th of June 1857; that she was not married to him prior to the second of January eighteen hundred, the time above stated she further declares that she is said widow.

[In her bounty land claim filed in 1855, the widow adds that she married her husband in Jasper County by one Jno Bean, JP [John Bean]; that her name prior to her marriage was Phebe Pate; that her husband died in Jasper County, Ga.]

[p 45: The widow survived the American Civil War and filed on October 18, 1867 for the restitution of her pension benefits.]

[Veteran was pensioned at the rate of \$100 per annum commencing March 4th, 1831, for two-year service as a private in the cavalry of the Virginia Continental line. Veteran's widow was also pensioned at \$100 per annum commencing September 4th, 1860.]
