Pension application of William Young ¹ W2509 Rebecca Young f50MD Transcribed by Will Graves 1/11/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Declaration of William Young in order to obtain the benefit of the Act of Congress of the 7^{th} of June 1832

State of Georgia, County of Columbia: SS

On this 11th day of September 1832 personally appeared before the Hon. the Superior Court of the County & State aforesaid, William Young a resident of the County and State aforesaid aged between Seventy and Eighty years, who being first duly sworn according to law doth on his oath make the following Declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th 1832.

That he entered the Army of the United States (as a substitute) in the year 1781 with Capt. Lavarsh and served in the fourth Maryland Regiment of the Infantry, under the following named officers, Major Roxbury commanded the Regiment, Capt. Lavarsh commanded the Company, Bettis was the Lieut. I served for and during the term of six months. I resided when I entered the service in Montgomery County in the State of Maryland. I was in the siege of York. He hereby relinquishes every claim whatever to a pension or an annuity except the present, and he declares that his name is not on the pension roll of the agency of any State.

I was born in Montgomery County & State of Maryland.

I have no record of my age nor no means of ascertaining my age.

I lived when I entered the service in the County of Montgomery & State of Maryland. I have lived the last thirty-three years in Columbia County & State of Georgia.

I entered the service as a Substitute for Bruce McGruder.

I received a discharge when I left the service but by whom signed I cannot from the length of time recollect which has been lost or mislaid.

I am known in my present place of residence to the Rev. Jeremiah Harris, Col. Zachariah Williams & Simmons Crawford & William Upton who can testify to my character for veracity and their belief of my Revolutionary services.



On June 29, 1853 in Richmond County Georgia, Rebecca Young of the city of Augusta aged 68 years filed for a widow's pension under the 1853 act stating that she is the widow of William Young, a pensioner of the United States for his service in the revolution; that she married him September 5, 1816; that her husband died in October 1835; and that she is still a widow.



[p 8: On April 19, 1855 in Richmond County Georgia, the widow, 69 years old, filed for her bounty land entitlement as the widow of a revolutionary war soldier; that she married him in Columbia County Georgia on September 5, 1816; that they were married by one JT Allen, JP; and that her name prior to her marriage was Rebecca Grinage [sic].]

[p 5: marriage license dated September 4, 1816 issued in Columbia County Georgia for the marriage of William Young to Rebeca Grenage [sic].]

[p 20: letter dated January 28, 1856 sent from Augusta Georgia addressed to the Commissioner of Pensions by Allen C Young in which he describes himself as the son of Rebecca Young, an applicant for a land bounty.

[Veteran was pensioned at the rate of \$20 per annum commencing March 4th, 1831, for service as a private for 6 months in the Maryland militia. His widow was pensioned in a like amount.]
