Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the<br/>software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." ## State of Illinois Jefferson County:

On this 24th day of April 1851. Before the Subscriber William Dodds Judge of the County Court in and for the said County in Open court personally appeared Abigail Taylor a resident of said County aged eighty-five years old who being first duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefits of the provision made by the act of Congress passed 7th of July 1838, granting pensions and half pay to certain Widows. That she is the widow of Westwood Waters commonly called West Waters who was a private in the Army of the revolution and served in the whole as much as two years or more in the State of South Carolina is not able to describe his services exactly but thinks he served in the Army from 1779 to 1781 and thinks that a part of the time he was under his uncle Captain Philip Waters [sic, Philemon Waters] and Colonel Thomas [John Thomas Junior] and General Sumpter [sic, Thomas Sumter] and also of serving under Colonel Waters [Philemon Waters] and part of the time he served as a Dragoon if she is not mistaken, and thinks it was while he served in his uncle Philip Water's Company and Colonel Thomas Regiment.

She further declares that she was married to the said West or Westwood Waters in Spartanburg District South Carolina by a Mr. Hood M. G. in the fall of 1784 and that her name before marriage was Abigail Renfrow.

And that her said husband West or Westwood Waters died in the year 1799 in Georgia. She further states that she was not married to the said Westwood Waters previous to his leaving the service, but that the marriage took place previous to the first day of January 1794, viz. at the time above stated, and in the year 1801 She was again married to a Mr. William Taylor in the County of Franklin in the State of Georgia and that her last husband William Taylor died in the County of Marion in the State of Illinois on or about the 16th day of April 1835 and from that time she has remained a widow that she has a family record on the belief of an old Bible that is here unto attached that it was written by her last husband William Taylor some thirty or forty years ago and that it is a true copy of their ages. Sworn to and subscribed before me this day and date above mentioned that she has lost his discharges, and that she was ignorant of the above law until recently.

[pp 17-19: certificate dated June one, 1851 from the South Carolina Comptroller Generals Office certifying the payments made to Westwood Waters for militia service during the revolution including payments for 62 days duty as a footman from the 20th of March to the 22nd of May 1780 in Captain Waters company & 59 days as a horseman from the 6th of April to the 4th of June 1781 and Captain Waters company Colonel Waters Regiment; for services rendered in Waters & Roebuck's Regiment since the fall of Charleston for Colonel Anderson's return; and a pay bill of Captain Philemon waters troop of Light Dragoons commanded by Colonel John Thomas and Sumter's Brigade from June 4th 1781 for 10 months service.]
