Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Before the Purpose of obtaining the benefit of "An Act for the relief of certain surviving Officers and Soldiers of the Army of the Revolution" approved on the 15^{th} of May 1828 –

I John Waggoner³ of Reading Township in the County of Perry in the State of Ohio do hereby declare that I enlisted in the Continental Line of the Army of the Revolution for and during the War and continued in its service until its termination at which period I was a private Soldier in Captain ____ Hares [sic, Bartholomew Von Heer's]⁴ Company and designated as General G. Washington's [George Washington's] life Guard – And I also declare that I afterwards received a Certificate for the reward of Eighty Dollars to which I was entitled under a resolve of Congress passed the 15th of May 1778 – And I further declare that I was not alone the 15th day of March 1828 on the Pension List of the United States

Revolutionary Claims Treasury Department, Sept. 16, 1818

John Waggoner, of Reading Township in the County of Perry in the State of Ohio has applied to the Secretary of the Treasury for the benefits of the act, entitled "An act for the relief of certain surviving officers and soldiers of the Revolution," approved the 15th of May, 1828. He states that he enlisted in the Continental line of the Army of the Revolution, for and during

the war, and continued until its termination, at which period he was a Private in Captain Von Heer's Troop Company, in the ____ regiment of the ___ line; and that he received a certificate for the reward of eighty dollars, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3rd of March, 1826, nothing

Revolutionary Claim

Under the act, entitled "an Act for the relief of certain surviving Officers and Soldiers of the Army of the Revolution," approved 15th of May, 1828.

Treasury Department 12 December 1828

The annexed paper, relating to the claim of John Waggoner under the above mentioned act, is respectfully referred to the Secretary of War, with a request that he will be pleased to cause me to be informed whether it appears, by any records of the war Department, that the claimant has received, or is entitled to receive, the bounty in land granted by Congress for service in the Continental Line of the Army of the revolution.

The undersigned has no knowledge of any troops appropriately denominated Washington's life guards,⁵ and has the supposed Hazens regiment to come the nearest to them, and therefore certifies that the records of this office do not show that John Waggoner of that regiment ever received or is entitled to bounty land of the United States. But it does appear that Warrant No. 13,895 issued on the 21st of January 1793 to John Wagner of Hazens regiment. It is necessary here to remark that the warrant of the above number appears by another entry to have been

Perry County SS} Personally appeared before me one of the Justices of the Peace within and for the County Jacob Fox⁶ of the County of Fairfield, in said State – who after being by me first duly Sworn deposeth and saith that he is the identical Jacob Fox who is placed on the list of Pensioners of the Revolution and was one of Captain Hares Company of Horse – and further Saith that during the Revolution he recollects that a person by the name of Waggoner was also a member of said Company of Horse and that he verily believes that John Waggoner (who lately resided in the County of Perry and State aforesaid and who has now removed to the County of Seneca in said State) is the Identical man, He founds disbelief upon the circumstance of the said Waggoner's knowledge of the most intimate Circumstances happening in the Company having had frequent conversations with said Waggoner – from the long lapse of time since he could have been intimate it is impossible for him to say positively that Mr. Waggoner ever deserted from the Company he further states that John Waggoner is an honest Man So far as he has any knowledge of him and in whose word or oath he would place the most implicit confidence.

On this Thirteenth day of September A.D. 1853, personally appeared before the undersigned Judge of the Probate Court of the State of Ohio & County of Sandusky, Sarah Waggoner, a resident of Washington Tp [Township] in the County of Sandusky and State of Ohio aged 75 years, who, being first duly sworn, according to law, doth, on her oath, make the following declaration, in order to obtain the benefits of the provision made by the act of Congress passed February 3rd, 1853, granting pensions to widows of persons who served in the Revolutionary War; that she is the widow of John Waggoner who was a Soldier in the war of the Revolution and was a "Revolutionary Pensioner" – I do not know under what Act, he drew his pension know nor when he commenced drawing – but his pension, per annum was \$96 and the place, Pittsburgh, Penn.

She further declares that she was married to the said John Waggoner on the 20th day of June A.D. 1833, in Somerset in the County of Perry in the State of Ohio by John Linn Justice of the peace and that her said husband died on the 15th day of December A.D. 1842; that she was not married to him prior to the second of January, 1800, but at the time above stated. She further declares that she is now a widow.
