Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Kentucky Bath County: Sct.

On this the 25th day of September 1840 personally appeared before me N. S. Jones a Justice of the Peace in and for the said County Elizabeth Sharp a resident of the County of Bath and State of Kentucky aged seventy-eight years who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 7th 1838 entitled an act granting half pay and pensions to certain widows. That she is the widow of Moses Sharp deceased who enlisted in the service of his Country in the beginning of the Revolutionary War for the term of two years in the County of Cumberland and in the State of Virginia in the Company commanded by Captain John Halcomb [John Holcomb or John Holcombe] of the County of Prince Edward Virginia at the same time that Moses Sharp volunteered & enlisted, the Declarant had two Brothers Thomas & William Walker who enlisted in the same company, And so did John Sharp the Brother of the said Moses Sharp enlist in the same company for the same length of time and they all served out their full two years except John Sharp who took sick and died in the Army. The Declarant lived in the neighborhood where the enlistment took place and recollects the transaction perfectly well, The declarant is fully satisfied that the said Moses Sharp was in the Army in different Companies nearly the whole time of the Revolution or at least until after Cornwallis was taken Prisoner [October 19, 1781] as will more fully appear by the discharge given the said Moses Sharp by his Captain Charles Allen which is hereunto filed and marked A, And also the furlough signed S. Meredith Com'd which is filed and marked B, Also John Woodson's Certificate of enlistment marked C, Also the Certificate of William Davies marked D. Also the Certificate of the Auditor James E Heath of Virginia marked E. All of which Documents are in the possession of the Declarant's Husband the said Moses Sharp at his death and has been preserved ever since by the Declarant. She further declares that she was married to the said Moses Sharp in the County of Cumberland in the State of Virginia on the 17th day of July 1783 And that her husband the aforesaid Moses Sharp died the 25th day of June 1820. That she was not married to him prior to his leaving the service but prior to the 1st of January 1794 viz. at the time above stated, She further declares she knows of no record of her marriage.



At a circuit court holden for the county of Bourbon at the courthouse in Paris on Tuesday the twenty third day of november in the year of our Lord one thousand eight hundred and nineteen.

Be it certified to the Governor and Council of the State of Virginia and all whom it may concern that it is proved before this court by Capt. Nathaniel Raine [S35609], that Moses Sharp of Bath county enlisted a soldier in Capt. Mortons [John Morton VAS765] company of the fourth Virginia Regiment for two years commencing February 1776 and ending in the spring 1778, which period he the said Sharp served and was honorably discharged by General Charles Scott [BLWt2055-850] at Valley forge in Pennsylvania.

Kentucky Sct.

At a court holden for the circuit of Bourbon at the courthouse in Paris, on Saturday the 13th day of May in the year one thousand eight hundred and twenty.

Be it certified to the Governor and council of the State of Virginia, and to all to whom it may concern, that it is proven before this court by Moses Sharp, that Capt. Nathaniel Raine of Bourbon county was an enlisted soldier in Capt Mortons company of the 4th Virginia Regiment for two years, commencing in February 1776 and ending the spring of 1778, which period he the said Raine served, and was honorably discharged by General Charles Scott at Valley forge in Pennsylvania.
