Pension application of William Sansom W311 Elizabeth D. f45VA Transcribed by Will Graves 1/11/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Tennessee Maury County: On this the 21st day of September 1846 Personally appeared before me Jesse M Gordon an acting Justice of the Peace in and for said County and a Justice of the County Court of Maury County, which is a Court of Record, Mrs. Elizabeth D Sansom a resident of said County aged seventy-one years who being 1st duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provisions made by the acts of Congress passed July 7th 1838, March 3rd 1843 and the 17th of June 1844 and Joint resolution 23rd of January 1845. That she is the widow of William Sansom who was a soldier in the Regular Army of the United States in the war of the Revolution, and of the Virginia line, that her husband the said William Sansom entered the service as an enlisted Soldier in the 7th Virginia Regiment in the early part of the year 1776 for a tour of during the war, that when he entered the service, he lived in Louisa County as well as this declarant recollects that he continued in the service till the close of the war, when he was regularly discharged, this declarant further states, that she has heard her husband say that he was under General Washington and was with him in 1777 when they wintered in Pennsylvania, that she has heard her husband the said William Sansom frequently speak of being at the Battle of Brandywine [September 11, 1777], at Guilford Court-House [March 15, 1781] and at the taking of Cornwallis [October 19, 1781] as she thinks he was at the Battle of Little York. And in fact she has heard him say that he was at or in the most of the hard fought Battles from the time he entered till the close of the war in 1781. But this declarant cannot give all the particulars in relation to his service nor can she give the names of all the Officers under whom he did serve while engaged in some one of the Battles he was wounded slightly being shot in his left arm, which was probably done at the Battle of Stony Point [July 16, 1779]. She further states that she was married to the said William Sansom on the 18th day of March 1790 in Wilkes County State of Georgia by David Creswell Esquire. That her husband the said William Sansom died in the Town of Washington County of Wilkes State of Georgia on the 16th day of March 1818. That since his death she has not intermarried but continues to be his widow. She further states, that she has frequently seen the discharge of her husband that it with [ink blot obliterates several words] was handed over to the publisher of the Washington Monitor a few days after his death, from which papers facts in relation to his services were ascertained and was inserted in said paper with the Obituary Notice of his death a slip from which paper was cut out containing said notice and is hereto attached, which is, and was intended for the notice of the death of her husband William Sansom, though it is inserted in said notice (Samson), it should have been Sansom. She further declares that she has not any documentary proof in support of her claim except her family record which shows the date of her marriage and of the birth of her children, which is the genuine record and in the handwriting of her husband William Sansom, deceased, and his last will and testament a part of which is written

in his own hand writing having his own proper signature thereto [line of text compromised and illegible] to the service of her said husband but this declarant cannot give them further than what she has heard her husband speak of in his lifetime.

DIED, in Washington, Wilkes county, on Monday, the 16th ult. William AMBON, Esq. in the 64th year of his age; He was among the many patriotic young men of Virginia, who, in 1775, the most doubtful and alarming crisis of the volution, enlisted themselves in the ause of independence. At this period he joined the 7th Virginia Regiment as privates was with it in some of the hardest fought battles of that war, and continued in the service of his country until the close of the revolutionary contest; after which, he removed to this state, and was among the early settlers of Wilkes county, where he lived and discharged many of the important duties of a useful citizen. Hiff disorder was an affection of the lungs, the long and severe pains of which were assuaged by the well grounded hopes of a christian He has left a widow and a large family of children to lament the loss of a kind husband, and an indulgant parent.

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 25th day of November 1783, in the name of William Sansom as Sergeant of Infantry for £77.7.6, which Certificate appears to have been delivered to Mr. Ford and was given for services prior to the 1<sup>st</sup> January 1782.

[The following are from <u>bounty-land records in the Library of Virginia</u> in the file of Temple Froman (VAS3647).]

I do hereby Certify that William Sansom a Soldier in the Continental Army under Capt. Holt Richeson [VAS1954] in the Seventh Virginia Regiment which was commanded by Alexander McClanaham [sic: Alexander McClenachan VAS2033] served the full term of three years, Eighteen month of the time a Quarter Master. given under my hand this 1<sup>st</sup> day August 1814.

Tho. Lipscomb [Thomas Lipscomb] Ens'gn to s'd Reg't.

King wm County to Wit. This day came Thomas Lipscomb personally before me and made oath to the above certificate, given under my hand as a magistrate for the afore said County this 1<sup>st</sup> day Aug't 1814
