Pension application of John Sanders W3874 Mary Sanders f99NC Transcribed by Will Graves 11/21/16

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee Claiborne County:

Be it remembered that this being the 4<sup>th</sup> day of January 1833 personally appeared before me Joshua H Chapman one of the acting Justices of the peace of the county of Pleas and Quarter Sessions held for said County the same being a Court of Record John Sanders aged about 80 years who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of an act of Congress passed June the 7<sup>th</sup> 1832.

States that he entered in the Service of the United States under the following named officers and served as herein stated – that he resided in Dobbs County in the State of North Carolina sometime in the year 1777 he was Drafted to perform a three months Tour of Duty and he does not now remember his captain's name but the company which he belonged to was attached to the regiment commanded by Colonel Richard Cayewell [sic, Richard Caswell] and we marched to various places in the State of North Carolina and we had a battle with the Scotch at the cross Creek Bridge [Moore's Creek Bridge, February 27, 1776] where we defeated the Enemy completely Routed them and after my time of service had expired I received my discharge from the commanding officer and returned home. This applicant begs leave to represent that some short time after he had been discharged from the last above-mentioned Campaign he enlisted his services in the cause of his Country for some considerable time, how long he does not recollect, that Captain Shepherd [John Sheppard] commanded the Company to which this applicant belonged and that said company was tacked [sic, attached] to the Regiment commanded by Colonel Shepherd [Abraham Sheppard] and we were stationed to guard the magazine in the Town of Kingston [Kinston] where this applicant served his country for the term of six months as well as he now recollects and he was then discharged and he returned home. He does not know the number of said regiment he states that he has no documentary evidence of his services nor does he know of any living Testimony by whom he can prove his services.

Where and in what year were you born – where did you live when you were called into service and where have you lived since the Revolutionary War and where do you now live [--] did you ever receive a discharge [--] tell the names of some of the regular officers who you know. He hereby relinquishes every claim to a pension or an annuity accept the present and declares that his name is not on the pension Role of any agency of any State whatsoever. He states that the best of his knowledge he did serve in the Revolutionary war for the time of 9 months putting the whole together.

Sworn to & subscribed before me January 4<sup>th</sup>, 1833

S/ J. H. Chapman, Justice of the Peace S/ John Sanders, X his mark [Samuel McBee, a Baptist minister, gave a standard supporting affidavit. John Huddleston gave a separate standard supporting affidavit.]

[p 16: On August 5, 1843 in Campbell County Tennessee, Mary Sanders, 81, filed for a widow's pension under the 1838 act stating that she is the widow of John Sanders, a Revolutionary war pensioner at the rate of \$30 per annum; that she married him in August 1780; that her husband died April 6, 1833 and that she remains his widow. She signed her application with her mark.]

[Facts in file: The veteran and his wife were married in Surry County North Carolina on August 17, 1780; her maiden name was Mary Ann, or Molly, Stotts (or Statts); she died August 18, 1845 or August 27, 1847, both dates appearing in different documents in this file.

[Veteran was pensioned at the rate of \$30 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 9 months in the North Carolina militia. His widow was pensioned in a like amount.]
