Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of North Carolina Wayne County: Court of Pleas & Quarter Sessions August Term 1818 Wiatt Warwick came personally into Court and made oath on the holy Evangelist of Almighty God that during the Revolutionary war he enlisted as a private soldier under Captain Benjamin Coleman and joined the Army at Tarborough in said State and served 12 months in the North Carolina Continental line in the 6th Regiment commanded by Colonel Lonril (as he believes) and that he got an honorable [discharge] in Wilmington North Carolina, which is lost.

This Deponent further states that he is very poor and needs the aid of Government and 72 years of age.

Josiah Mainor¹ made oath in open Court that the above named Wiatt Warwick served in the 6th Regiment of the North Carolina Continentals, as a private soldier and believes that he got a discharge at Wilmington

District of North Carolina: Superior Court of Wall Wayne County

On the 15th day of October in the year of our Lord 1820, Personally appeared in open Court (being a Court of Record having a jurisdiction unlimited in amount proceeding according to the Course of the Common Law, and keeping a record of its proceedings and having power to fine and imprison), Wiat Worrick a resident of Wayne County in the State of North Carolina, aged sixty-four years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provision made by the Acts of Congress of the 18th March 1818 and the 1st May 1820. That he the said Wiat Worrick enlisted for the term of twelve months, on or about the middle of March in the year 1781 in the State of North Carolina in the Company commanded by Captain Coleman in the Regiment commanded by Colonel Litle [sic, Archibald Lytle] in the line of the State of North Carolina on the United States Continental establishment. That he continued to serve in the said Corps until the 15th day of March in the year 1782 when he was discharged from the said service. In the Company commanded by Captain Coleman in the Regiment commanded by Colonel Lytle at Wilmington in the State of

North Carolina. That he was in no Battle that he was sick and in the Hospital at the time of the Battle at Eutaw Springs in South Carolina and that he has no other evidence now in his power of his said Services. And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed -- viz.

Schedule of the Property of Wiat Worrick taken the 30th day of September 1820 One cow & calf, one Heifer, one sow & 8 young hogs, one pot, one Dutch oven, one skillet, 9 earthen plates, 8 glass bottles, 4 earthen jugs, one pewter dish, 3 pewter spoons, 3 earthen bowls, one earthen basin, one water pail, one Bread Trade, one Basket, one candlestick, one tea pot, 5 teacups & saucers, one sugar dish, one spell mug, one case knives & forks, one chest, one wheel & cards, one trumpet, one sifter, one auger, one axe, one grubbing hoe, 2 weeding hoes, four barrels, one table, one gun, one old linen wheel, Flesh [?] forks, one drawing knife, one pair small Steelyards, one pper [?] box, two sitting chairs, one slay & Harness, one old Loom, Three gimblets, one yearlin hide of leather, one milk piggin, two old ditto, one Testament, Two Hymn Book, one little Song Book, one Tinkle [?] Bottle, one vial, one well bucket, one Tub, old Tray, about eight Thousand corn hills, Fodder & Peas in the same, eight hundred Potatoe Hills, Six Dunghill Fowls.

The declarant states that he is a farmer by occupation and is 64 years of age Quite unable to do much labor, Has a wife who is about 58 years old. She is also quite infirm.

State of North Carolina Office of Secretary of State

I William Hill, Secretary of State, in and for the State of North Carolina, do hereby certify that it appears from the muster-rolls of the Continental line of this State in the Revolutionary War, that Wyatt Warwick a private Soldier and Captain Doherty's Company of the 10th Regiment, entered the service on the __ day of __, 1781, for the term of __ and that he served to the 25th May 1782, when his time was out.

[Facts in file: Veteran died March 6, 1830, place not shown. The veteran married December 25, 1790 in Wayne County North Carolina or in Greene County, North Carolina, to a Mrs. Sarah Wilson. He had been previously married. There are no particulars in regard to his former wife. The day and place of birth of Sarah Wilson, the names of her parents and the name and date of death of her first husband are not shown. Soldier's widow, Sarah, was allowed a pension on her application executed September 5, 1843 at which time she stated she was 80 years old and living in Sampson County, North Carolina. The veteran had children by his first marriage but none by his marriage to Sarah Wilson. The only name of a child that is given in the file is that of a son John Warwick, who, in 1843, was in the 64th year of his age and residing in Cumberland County North Carolina. Sarah Wilson Warwick had a daughter, Sarah or Sally Wilson by her former

marriage. One Jacob Warwick was present at the marriage of Wyatt and Sarah Warwick, his relationship if any to the veteran is not stated and Jacob was deceased by 1843. In 1843 Fany Wilson made affidavit in Cumberland County North Carolina that Sarah Wilson Warwick was her paternal aunt, the names of her parents are not given. In 1844, one John Wilson aged 46 gave affidavit in Sampson County North Carolina in support of the widow's application. In 1845, one Nicy Wilson made affidavit in Sampson County North Carolina also in support of the widow's application. The relationship, if any, of John and Nicy Wilson to the widow is not stated.]

[Veteran was pensioned at the rate of \$8 per month commencing August might team, 1818, for service in the North Carolina line.]
