Pension application of Lewis Keizer [Keiser] W4709 f12PA Transcribed and annotated by Will Graves 6/24/23

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

On this 23rd day of August 1836 before me Matthias S Richards a Judge of the Court of Common Pleas in and for the County of Berks in the State of Pennsylvania Personally appeared Anna Elizabeth Keiser, widow of Lewis Keiser deceased a Resident of the County and State aforesaid Aged Seventy five Years and past, who being first duly Sworn according to Law, doth on her Oath make the following Declaration, in Order to obtain the benefit of the provision made by the Act of Congress passed July 3rd 1836. That she is the widow of Lewis Keiser deceased who was formerly a private duly Enlisted in the Service of the United States in the War of the Revolution, and in the Company of Dragoons Commanded by Captain Bartholomew Von Heer¹ and that her said Husband continued to serve in said Company for a Term of Two Years and Six Months; that at present she cannot state the day & year in which her said Husband entered the Service and that she had in her power a Certificate drawn under the Hand and Signature of said Captain Von Heer Stating in said Certificate that her said Husband Lewis Keiser was duly Enlisted a member of said Captain's Company of Dragoons and in said Certificate was fully mentioned that her said Husband was then entitled to receive the Depreciation money in pursuance of the Act of Congress and that the Same Certificate which was in her possession was presented heretofore by the Honorable Henry A. Muhlenberg to the Auditor's office of the United States and it then appeared in said Offices that Von Heer had drawn the Amount due her said Husband the Depreciation monies aforesaid reference hereunto had will more fully appear in the Revolutionary Records of the War Department of the United States and She further Declares that She was Lawfully Married to the said Lewis Keiser in Reading Pennsylvania by the then Pastor William Boas of the German Reform Presbyterian Congregation that she was Married as aforesaid on the 22nd day of January A.D. 1781 and that her Husband was in actual Services during the time in which She was his wife a Certificate of her said Marriage given under the Hands of the present Pastor of said Church namely William Pauli is hereunto annexed will fully prove my Marriage and that her Maiden Name was Anna Elizabeth Smith and that she is now in the receipt of a Pension annuity of Forty Dollars from the State of Pennsylvania & payable semiannually at Harrisburg Pennsylvania July 1st and January 1st in every year and She further declares that her Husband the said Lewis Keiser Died on the 12th day of November A.D. 1788


