Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Maryland Frederick County SS

On this 22 day of May 1845 personally appeared Mary White before the Subscriber one of the Associate Judges of the 5th judicial District of Maryland in open Court a resident of the County and State aforesaid aged 79 years 8 months and Some days who being first duly Sworn According to law doth on her oath make the following Declaration in order to obtain the benefits of the provisions made by the act of Congress passed July 4th 1836. She further declares that she is the widow of Joseph White who was a soldier in the war of the Revolution and served as a private. He received 100 acres of land for said service in the State of Ohio Warrant No. 4874 was issued by the Virginia in favor of Joseph White for three years in the Virginia Continental line December 11th, 1798 the officers names I cannot recollect & she further declares that she was married to the said Joseph White the 13th of March 1793, that her husband the aforesaid Joseph White died the 7 day of January 1805, that she was not married to him prior to [his] leaving the service but the marriage took place prior to the first day of January 1794 viz. at the time above stated.

[p 7: On May 28, 1855 in Harrison County of Ohio, Mary White (widow of Joseph White), 89 years of age, a resident of Harrison County of Ohio filed for her bounty land entitlement by application in which she states that her husband was a private in the 10th Virginia Regiment commanded by Colonel Daniel Morgan. She signed her application with her mark.]

November Station 1781, that a Certificate issued on the 15th day of April 1785, in the name of Joseph White as a soldier of Infantry for £57.19.3, which Certificate appears to have been delivered to General Wood and was given for services prior to the first January 1782.

On this 22 day of July 1845 before me the Subscriber a Justice of the peace in and for the aforesaid county personally appeared Frederick R Fulton and made oath in due form of law and deposeth and saith that he was personally acquainted with Joseph White and Mary White his wife who now claims a pension of the United States for three years service rendered in the Virginia Continental line in the war of the Revolution by her husband Joseph White and knows Mary White to be the Identical widow of Joseph White who got one hundred acres of Virginia land Bounty for being in the war of the Revolution and says that he lived in the State of Ohio for some years and knows the Virginia land bounty of the aforesaid Joseph White that he got lies near Chillicothe Ohio and can say that he is acquainted with Joseph White & Mary White's children and three of them living in the State of Ohio at this time and one of them in New Market State of Maryland and one of them died in the aforesaid State and know the aforesaid Joseph White to be the Identical person that got Virginia bounty land in the State of Ohio

[p 33: On July 21, 1845 in Frederick County Maryland, John Jackson gave testimony substantially identical to that given by Patrick R Fulton as set forth above except this deponent

adds that he recalls seeing the land bounty papers in the possession of Joseph White and that he, the deponent, lived within 1 mile of Joseph White at the time Joseph died.
