[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Virginia Loudoun County: SS

On this the 13th day of August 1839, personally appeared before the Court of the County and State above named Mary Magdalena Schumacher a resident of the County and State aforesaid aged sixty-six years of age the 5th day of February last past, who being duly sworn in open court according to law, doth on her oath make the following declaration, in order to obtain the benefit of the provision made by the act of Congress passed July the 7th 1838, entitled "An act granting half pay and pensions to certain widows." —

That she is the widow of George Schumacher who served as a private soldier during the war of the Revolution, that she was married to him in June 1789, and that he the said George Schumacher died sometime in the fall of the year 1805, and that she has never married after which; but still continues the widow of the said George Schumacher. She moreover avers that she was not married to him prior to his leaving the service but the marriage took place previous to the 1st day of January 1794 – viz. – At the time above stated – She further declares that she has frequently heard her deceased husband, the said George Schumacher, say that he was an enlisted soldier of the war of the Revolution. She cannot state the time he entered the service or the time he left the same nor can she name any of the officers under whom he served. She can only say that she has repeatedly heard him say that he was in service above stated and that he went from this (Loudoun County) to Carolina she states moreover that she has no record of her marriage, save the church record, and has no family record of any kind, and that she is not on the pension list of any State.

[f p. 12: Simon Schumacher gave testimony on November 28, 1839 in Warren County Ohio that George Schumacher, husband of Mary M Schumacher of Loudoun County Virginia, entered the service as a substitute for one James Templen to serve a term of eighteen months beginning he thinks in the year 1780 at least two years prior to the close of the war; that while serving as a substitute George Schumacher enlisted for during the war and served until the close of the war, not less than two years; that George Schumacher was legally married to Mary M Frantz [?]¹]

On this 12th day of August 1839, before me Thomas J Marlow a Justice of the Peace in and for said County, personally appeared James Templen [could be James Templer] of the County and State aforesaid, and made affirmation in due form of law, that he was well acquainted with George Schumacher for some years prior to the close of the revolutionary war, and that, towards the latter part of the War, he, the Deponent was drafted in this (Loudoun County) for eighteen months, and that he hired the above named George Schumacher as a substitute to supply his place, and he knows that the said Schumacher March from this County towards the South, and he is satisfied that he never left the service until after the close of the War, He further states that he was also well acquainted with the said Schumacher some years after the war, and is under the impression that he served until after the close of the War he cannot tell the names of any of the Officers under whom he served nor any particulars in relation to said service, but he is satisfied that he served as above stated, viz. to the close of the War.
