Pension application of Edward Shacklett W6037 Elizabeth Shacklett f28VA Transcribed by Will Graves 1/29/12: rev'd 5/10/21

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Virginia Fauquier County: SS

On this 25th day of July 1838 personally appeared before me a Justice of the Peace in the County aforesaid Elizabeth Shacklett a resident of the County aforesaid, aged Seventy-two years, who being first duly sworn, according to law, doth, on her oath, make the following declaration, in order to obtain the benefit of the provision made by the act of Congress passed July 7th 1838 entitled, "An act granting half-pay and pensions to certain Widows:" That she is the widow of Edward Shacklett deceased who was a Sergeant in a Company of Artillery commanded by Captain Nathaniel Burrell [Nathaniel Burwell] in the 1st Regiment of Artillery Commanded by Colonel Harrison [Charles Harrison]² that her said husband was a resident of Surry County Virginia when he entered the Army and the discharge of Lt. Col. Carrington [Edward Carrington], dated "Park near Morris Town, January 10th 1780" and Captain Burrell's Certificate dated "July 22nd 1778" is relied on by her as evidence of the Service of her said husband and is enclosed with her declaration. She further declares that she was married to the said Edward Shacklett on the 10th of May 1782 by the Reverend Mr. Thompson in the County of Fauquier; that her husband, the aforesaid Edward Shacklett died on the 23rd day of April 1826; that she was not married to him prior to his leaving the Service, but the Marriage took place previous to the 1st day of January 1794, viz.: at the time above stated.

Sworn to and subscribed on the day and year above written before me: – And I further certify from personal observation that owing to bodily infirmity the said Elizabeth Shacklett cannot attend court to make the above declaration and that she is a lady of high respectability and I have the utmost confidence in her evidence. 

Edward Shacklett late a Serjeant of Capt. Burwell's Company in the first Regiment of Artillery commanded by Colo. Charles Harrison, having served the term for which he stood engaged is hereby discharged the service of the United States. His good Behaviour as a Soldier, entitles him to the respect & esteem of all his Countrymen.

Given under my hand at the park of Artillery near Morris-town this tenth day of Jan'ary 1780
