#### Pension application of John Simmons W6063 Transcribed by Will Graves

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

## Revolutionary Claims<sup>1</sup>

For the purpose of obtaining the amount of pay accruing to me for the half-year ending on the 2nd day of September 1828 under the act entitled an act for the relief of certain Surviving officers and Soldiers of the Army of the Revolution approved the 15th May 1828 –

I John Simmons in the County of Columbus in the State of North Carolina do hereby declare that I was a Private Soldier of the Army of the revolution in the Continental line and that I have been found entitled by the Secretary of the treasury under that act to the pay of a private in said line witness my hand this first day of November in the year 1828 before me

Personally appeared James Stanaland<sup>2</sup> and Samuel Hickmon<sup>3</sup> of said County who did severally make oath that John Simmons by whom the foregoing declaration was made and subscribed is well known to them to be the person therein described and that he is generally reputed and believed to have been a private soldier in the Army of the revolution war in manner as therein stated and the said declaration was made and subscribed by the said John Simmons in their presence on the day and date above written witness my hand this first day of November 1828

now in session John Simmons a resident of Columbus County North Carolina aged sixty-nine years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefits of the provision made by the act of Congress passed June the 7th 1832. That he enlisted in the Army of the United States in the year 1781 with Colonel Peter Hory [sic, Peter Horry] for one year and received as a bounty Eleven guineas he believes - that he was at the time of his enlistment a resident of Brunswick County North Carolina and enlisted in Kingston District South Carolina and served in a light horse company of the South Carolina line he thinks under the following officers that he was first put under the command of Captain William Weathers and was marched across Santee and joined Colonel Shelby then he was marched down Cooper River where we surprised and took about eighty of the British soldiers in a church and conveyed them to General Marion – that he remained with the Army in the neighborhood of Santee and Cooper River during the winter, in the spring he was marched to George Town [Georgetown] South Carolina, after serving about 9 months, he believes he obtained leave of Colonel Horry to enlist with Captain Rue which he did for 3 years in the 2nd Regiment of the South Carolina line he thinks, that he enlisted in George Town South Carolina and was stationed at Cat Island below George Town under the command of Lieutenant Jordan or Torance he believes and that he was marched backwards and forwards between George Town & Cat Island until he was discharged after peace which he believes was about 12 months but does not recollect by whom he was discharged.

This day personally appeared before me Edward Conner<sup>4</sup> who being duly sworn saith that he was well acquainted during the Revolutionary War and ever since with John Simmons the applicant and to his knowledge, the said John Simmons enlisted in a company of light Horse commanded by Colonel Peter Horry but does not know what time he enlisted or the term of the service, and further knows that he was under the command of Captain Weathers and to his belief served nine months and then enlisted in the 2nd Regiment of the South Carolina line with Captain Rhew soon after this this deponent was marched to Fort Davidson where he remained about 15 months and then was discharged and on his return home found that the father of this applicant was killed in the service and that his mother was likely to suffer that this deponent Lieutenant Conway & Dewit applied and tried to get a substitute for said Simmons to offer in his place that he might return home and take care of his mother and family but failed this deponent knows not when he was discharged.

This day personally appeared before me Samuel Hickman<sup>5</sup> who being duly sworn saith that he was well acquainted with John Simmons this applicant for a pension and to his knowledge the aforesaid John Simmons did enlist at the same time with this deponent on the 10th or 11th of October 1781 as well as can be recollected with Colonel Peter Horry in a

Regiment of light horse for 12 months and in the year 1782 this deponent obtain the leave of Colonel Horry to enlist in the regular service for 3 years which he did with Captain Rhue of the 2nd Regiment and in a very short time after John Simmons this applicant enlisted with Captain Rhue of the 2nd Regiment shortly after this deponent was marched to the Congaree & they were separated during the war.

[p 14: On May 13, 1844 in Columbus County North Carolina, Felix are powerful, 26, filed a claim as the son-in-law of John and Leodosia Simmons claiming the pension due his mother in law; he states that the veteran, John Simmons died November 15, 1836 leaving Leodoais his widow who died January 21, 1844 leaving only 5 children surviving her to wit: Priscilla the declarant's wife; Luke R Simmons; John A. Simmons, Susannah Simmons who intermarried with Matthew Johnson; and Darkes [sic, Dorcas?] 72 intermarried with Jackson Neeley.

[p 11: Isaac Simmons, 76, testified in Brunswick County North Carolina on April 4th, 1844 that he was present at the marriage of John Simmons, pensioner, to Leodosia Gore in September 1789.

Jacac Simmonda

[Veteran was pensioned at the rate of \$87.50 per annum commencing March 4th, 1831, for 9 months service in the cavalry and 15 months service in the infantry, all in the South Carolina militia.]
