Pension application of William Sweatman W6116 Lavinia (Lavina) fn
Transcribed by Will Graves 3/26/11

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Georgia Thomas County: On this 6th day of March 1830 Personally appeared in open Court it being a court of record for the County aforesaid William Sweatman a resident of the said County, aged sixty-six years who being duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the acts of Congress of the 18th of March 1818 and the 1st of May 1820; that he the said William Sweatman enlisted for the term of 12 months of the day of in the year of in the State of North Carolina in the Company commanded by Captain Joseph Thomas Rhodes in the Regiment commanded by Colonel Armstrong in the line of the State of North Carolina on the Continental establishment; that he continued to serve in said Corps until __ when he was discharged from the service in or near Bacons bridge in the State of South Carolina that he hereby relinquishes every claim to a pension except the present; that his name is not on the roll of any State, except North Carolina; and that the following all the reasons for not making earlier application for a pension. That he considered himself competent to procure a decent Support for his family by his personal labor and felt it a shame to burden government with his support while such was his situation. But old age and infirmities have compelled him to throw himself poor and penniless on the Government of his Country.

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

That the following property viz. 275 acres of pine land in North Carolina worth \$300 3 head of horses worth \$120, small stock cattle worth \$21 Stock of hogs worth about \$50 was all the property that I owned on the 18th of March 1818 except necessary bedding & clothing & farming tools & ??

That it is not in my power at this time if it will be at all to procure a certificate from the Sheriff of the County in which I lived in North Carolina I having removed to Georgia since the Sale of my effects. Since my removal my horses all died that is to, my cards have been spent for the rent of land and bread for my family and for which I am partly embedded yet age and misfortune their heavy on me and without public or private Charity I see very little prospect but suffering I am a farmer by occupation my family are 8 in number of myself inclusive that is Sarah aged 28, Eliza Anne 22, Alice aged 20, John 18, Zacheus 16 unable to labor on account of his being afflicted with the palsy; George W Sweatman a grandson 15. And my wife Lavina Sweatman age 60 my oldest hired out to try and pay my debts incurred for provisions and rent.

Georgia Thomas County: Personally appeared before me William Sweatman who being duly sworn deposeth and saith

That he served 12 months during the revolutionary war between Great Britain and America as a private Soldier in the North Carolina Continental line under the Command of Colonel Armstrong and in the company of Captain Joseph T Rhodes and during my time of service was in the battle of Eutaw [Eutaw Springs] under General Greene. I was at the expiration of my Service marched to Wilmington North Carolina and there discharged. But from the long lapse of time and removing to another State I have lost my certificate the deponent further states that he has never received the first cent from the United States nor from any source in bounty money or pension for said Services either when they were performed or since.

[fn p. 49: On April one, 1837 in Thomas County Georgia, Loviny Swetmon, 66, filed for a widow pension under the 1836 act stating that she is the widow of William Swetman, a revolutionary war pensioner; that she married him on the 17th or 18th day of August 1787; and that her husband died December 24, 1835.]

[fn p. 19: On February 2, 1841 in Thomas County Georgia, Levina Sweatman, 70, filed for a widow's pension under the 1838 act stating that she is the widow of William Sweatman, a pensioner for his service in the revolution; that she married him on the 17th or 18th of August 1787; that her husband died December 24, 1835.]

[fn p. 5: On May 13, 1851, the justices of the Thomas County Georgia Inferior Court found that Levina Sweatman died February 5, 1850 leaving the following children surviving are who had been heard from in the last 3 or 4 years namely Allice Davis formerly Allice Sweatman, Sarah Carroll formerly Sarah Sweatman, Eliza Alderman formerly Eliza Sweatman and Mary Brown formerly Mary Sweatman.]
