Pension Application of William Taylor W6233 Transcribed and annotated by C. Leon Harris

To the Honorable John C. Cahoun [sic: John C. Calhoun] Secretary of the Department of War of the United States of America

J. Alfred Metcalf Circuit Judge in and for the fifth Judicial District of the Commonwealth of Kentucky and sole Judge of the Circuit Court in and for the County and Circuit of Jefferson in said District, do hereby certify that on this day, William Taylor came before me and upon oath declared – That he is a citizen of the United States, and a resident of the County of Jefferson aforesaid – that in the Spring of the year 1776 he entered the army of the revolution as a first Lieutenant in Captain Francis Taylor's Company [pension application R19418], in the second Virginia Regiment of the Continental establishment which Regiment was commanded by Colonel William Woodford; In the Spring of the year one thousand seven hundred and eighty he was appointed a Major and ordered to join the ninth Virginia Regiment of the Continental establishment, then stationed at Pittsburg commanded by Colonel John Gibson. That in the Spring of the year one thousand, seven hundred and eighty one he (being then stationed at Wheeling in Virginia) received a letter from said Colonel John Gibson, advising him that he (said William Taylor) had been left out of the service by an arrangement made at Chesterfield Courthouse, in Virginia [12 Feb 1781]. That his Commission as Lieutenant as aforesaid was issued and dated in the Spring one thousand seven hundred and seventy six, and that he continued in the military service of the United States as before stated until the spring of the year one thousand seven hundred and eighty one, when he quitted in consequence of the arrangement of the regiments as before mentioned; that he never was commissioned as a major, but acted as such for a year and more; that his commissions as lieutenant and captain were written upon paper, and are worn out and no longer in existence; and that from his reduced circumstances he needs the assistance of his country for support

Major John Harrison also made oath before me, that he knew that the said William Taylor was in the military service of his country during the revolutionary war as an officer upon the continental establishment, for about six years & that a part of the time, the said Taylor acted as major in the regiment to which the said Harrison belonged [1 May 1818]

## State of Kentucky

On the 12<sup>th</sup> day of September 1820 personally appeared William Taylor in the County Court of Jefferson County in the state aforesaid a court created by the Constitution of the state and being a Court of Record made so expressly by law which keeps a record of its proceedings and also has power to fine and imprison and the said Taylor who is aged sixty seven years and a resident of the Town of Louisville in the said County and his occupation a Tavern Keeper at present being first sworn according to law doth on his oath declare that he served in the Revolutionary War as follows. In the year 1775 he served as a volunteer in the minute service and was at the taking a tender to a ship at Hampton – that he was at the battle of the long bridge in Virginia [sic: Battle of Great Bridge, 9 Dec 1775] that while there he received a Commission of first Lieutenant and the Company was attached to the Second Virginia Regiment on the Virginia troops marched to the South [to relieve besieged Charleston SC, spring 1780] he was promoted to the rank of major under Colo John Gibson and continued in the military service of the United States throughout the Revolutionary War and that he fought in the principle battles of Brandywine [11 Sep 1777] and German Town [Germantown, 4 Oct 1777] and Monmouth [28 Jun 1778] and that for said service a pension has been granted him, the Certificate for which is numbered 15,702 and dated the 6<sup>th</sup> nov 1819

And the said Taylor further declared on oath that he was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that he has not since that time by gift sale or in any manner disposed of his property or any part thereof with intent thereby so to diminish it as to bring himself within the provisions of an act of Congress entitled "an act to provide for certain person engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18<sup>th</sup> day of March 1818 and that he has not nor has any person in trust for him any property or securities contracts or debts due to him nor has he any income other than what is contained in the Schedule hereto annexed and by him subscribed. The said Taylor also declared on oath that the following are the names ages and sexes of his children who live with him in his family towit 1<sup>st</sup>. Robert H C Taylor aged about eighteen years who assists him in the said Tavern and who is not more than competent to provide for himself not having been in any other business –

That the wife of the said William Taylor is about forty six years old That he the said Taylor keeps his present Tavern on lease from year to year at six hundred dollars rent by which he looses at least three hundred dollars per year and cannot give it up for the want of a home of his own to move to – that he the said Taylor owes to the Bank of Kentucky \$1167. To the Louisville Bank \$500 and to Mr Thomas Prather about \$1500 and that the amount of debt which he owes is about four thousand Dollars.

He further stated on oath that his five youngest children before named are an expense to him and cannot contribute to their support in any beneficial degree and that he the said Taylor is infirm and inactive and with difficulty pursues his occupation aforesaid and will not much longer be able to pursue it at all.

He further declares on oath that if he shall not recover the 198 acres of land mentioned in his schedule that he will not be able to own a home and will be totally ruined.

One [illegible word] Judgment for about £930 with cost against the Estate of John Handley which is insolvent and nothing can be got

Half of 1000 acres of land deed by s'd John Handley to James Patton & myself to which s'd Handley's title is not good and the land cannot be obtained – price allowed Handley being two dollars per acre. The possession of the land is held under an adversary title with the older patent; and suit was brought for the land in order to have recourse against Handley, who has since died and his estate is insolvent Wm. Declaration of Maj Wm Taylor Sen'r in order to be restored to the Pension List, under the act of the 1<sup>st</sup> of March 1823

State of Kentucky, Jefferson County, Ss. On this 20<sup>th</sup> day of March, 1824, personally appeared in

open Court, before John P Oldham sole Judge of the Jefferson Circuit Court, being a court of record, Maj. Wm Taylor Sen'r., a resident of Oldham County {formed by an act of the late session of the Legislature of Kentucky, and in which no superior court of record has yet been organized} aged seventy-one years, who being first duly sworn according to law, doth on his oath make the following declaration, in order to obtain the provision, made by the acts of Congress, of the 18<sup>th</sup> March 1818, and the 1<sup>st</sup> May 1821 [sic], that he the said Wm Taylor, Sen'r. entered the service in the summer of 1775, as a volunteer or minute man, in the company of Capt Spencer, (particular date not recollected) that in the winter of 1775 - 1776, he was appointed 1<sup>st</sup> Lt. in the Company of Capt Francis Taylor, (his brother) attached to the 2<sup>d</sup> Regiment of Virginia commanded by Col Woodford, in the Virginia Line, 1<sup>st</sup> Continental establishment – that he was subsequently promoted to the rank of Captain, and then to that of Major and continued in the Army until the year 1781 – and that he was afterwards, at the reduction of the army arranged out of the service as a junior officer, at Chesterfield Court-House, Virginia; that his name has been placed on the pension list and dropt therefrom on account of his property. #Note = The said Wm Taylor Sen'r. has in his possession 2 horses (1 blind;) 4 cows, 3 calves, 1 old cart & 8 head of hogs, which should have been enumerated in the foregoing schedule. The cart, two cows and calves, and the hogs above mentioned are the fruits of private charity; and he was during the last year indebted to the same source for nearly all the bread and meat used in his family – and this year his meat has been contributed in like manner. The value of the property above described is supposed to be about \$160.00 [signed] Wm. Taylor Sen'r

For the purpose of obtaining the benefits of an act, entitled "an act for the relief of certain surviving officers and soldiers of the army of the revolution," approved on the 15<sup>th</sup> of May 1828, I, William Taylor Sr. of [blank] in the County of Oldham in the State of Kentucky, do hereby declare that I was an officer in the continental Line of the army of the Revolution and served as such, to the time when the arrangement of the army provided by the resolves of Congress of the 3<sup>rd</sup> and 21<sup>st</sup> October 1780 was carried into effect, and was reduced under that arrangement at which period I was a Major in the 9th regiment of the Virginia Line. And I also declare, that I afterwards received a certificate (commonly called a commutation certificate) for a sum equal to five years pay, which sum was offered by the resolves of

congress, of the 22<sup>nd</sup> March 1823, instead of the half pay for life, to which I was entitled under the resolve of the 21<sup>st</sup> October 1780.

And I do further declare that I have received as a pensioner of the United States since the 3<sup>rd</sup> day of March 1826 the sum of four hundred and eighty dollars paid to me by the Agent for paying Pensions in the state of Kentucky [signed] Wm. Taylor Sen'r

NOTE: On 5 Aug 1851 Richard F. Taylor of Henry County KY, one of the sons and heirs of William and Elizabeth Taylor, both deceased, applied for the pension owed to his mother. He stated that his father died on 29 Mar 1830, and his mother died on 29 Mar 1849 leaving the following children: Richard F. Taylor, Eleanor M. Berry, and Eliza O. Horning. He stated that his parents were married in Jefferson County KY on or about 25 July 1796. The file includes a copy of the record of the marriage of William Taylor and Eliza Courts in Jefferson County on 25 July 1796. In a letter dated 9 May 1894 from Windsor MO, Richard F. Taylor stated that he wished to apply for membership in the "Society of the Sons of the Revolution" in St. Louis MO, and that his father "was one of seven brothers all in the service – one of them I believe in the Navy."

I hereby certify that Major Wm. Taylor entered into the Virginia Cont'l Army 2nd Reg't in the Fall of 1775.

Given under my hand this Eleventh of May 1799.

I do Certify that the within mentioned Major W. Taylor was an officer in the 2<sup>d</sup> Virginia Regiment when I entered the service which was about the 10<sup>th</sup> of February 1776 and that he continued in service with said Rank until the Close of the War Jno Nelson Capt [John Nelson1 S35537]

5 Virg'a Reg't 6<sup>th</sup> Aug 1799

I do Certify that Major William Taylor entered into the Minute service & in the Regiment commanded by Colo. Edward Stevens [VAS1922], some time in the summer 1775 as a private, and continued in said service until he was appointed a Lieutenant in the 2<sup>nd</sup> Virginia Continel Regiment which I think was some time in the Winter of 1775-76 and Continued in service until the close of the war at which time he ranked a Major
