Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Declaration

In order to obtain the benefit of the act of Congress of the 7 July 1838 entitled an Act granting half pay and pensions to certain widows

State of Georgia, Walton County SS

On this 6th day of May 1845 personally appeared before the Honorable the Inferior Court held in and for the County aforesaid the same being a Court of record Mrs. Sarah Thrower a resident of said County and State aged Eighty years past – who being first duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefit of the provisions made by the Act of Congress of the 7th of July 1838 entitled an Act granting half pay and pensions to Certain Widows. That she is the widow of Benjamin Thrower who was a Soldier and served in the War of the Revolution in the North Carolina Militia. That she can state nothing further of her own knowledge and knows of no person living who can give a narrative of her husband's services other than Joel Etheridge¹ of Crawford County Georgia whose statement she refers to for proof of her said husband's Services. That she has no Documentary evidence in her possession of the fact further the [sic, than the] Comptrollers Certificate. And deponent further states that the said Benjamin Thrower died on the 26th day of July 1820 in Wilkerson County State of Georgia. And deponent further declares that she was legally married to the said Benjamin Thrower on the 5th day of June 1783 in Halifax County – State of North Carolina by Matthew Rabun a Justice of the Peace. That she was born in the year 1764 as she has always understood and believes and was married in the 19th year of her age on the day and month aforesaid and resided in Halifax County until her third child was born and removed from there to South Carolina from thence to Georgia Putnam County from thence [to] Jasper from thence to Wilkerson County – all of the State of Georgia where her said husband died on the day aforesaid leaving her as his widow. That she has no Documentary evidence in support of the foregoing statements her family Bible having been destroyed as she is informed. That she has remained a widow ever since the period of her husband's death that she was not married prior to her husband's last service But was married prior to the first day of January 1794 the is at the time above stated all of which will more fully appear by reference to proof hereunto annexed.

Be it known that on the 9th day of January 1844 before me Patrick M. Calhoun a Justice of the Peace in and for the County and State aforesaid, personally appeared Joel Etheridge a resident of said County and State aged Eighty-Two years, who being first duly sworn according to law doth on his oath make the following statement. That he was acquainted with Benjamin Thrower from his boyhood. That he entered the service in Company with Benjamin Thrower sometime during the year 1780, that both he and said Benjamin Thrower entered the service at the same time, as North Carolina Militia under the Command of Captain John Williams. The Regiment command by Colonel Sowell [Benjamin Seawell], that deponent and Benjamin Thrower, both entered the service from Halifax County in the State of North Carolina and served a three months tour, and at the end of said tour said Benjamin Thrower was honorably discharged

during which tour or term of service, they the said Etheridge and Benjamin Thrower rendezvoused at Franklin in the County of Halifax North Carolina, from thence they marched through Wake Court house, now Raleigh, thence to Salisbury in the County of Rowan thence to Charlotte in the County of Mecklenburg all of which latter places are in the State of North Carolina, after passing through Charlotte they were stationed near said place, until our tour of service expired and that said Benjamin Thrower received from his Captain an honorable written discharge, deponent further states that said Benjamin Thrower entered the service afterwards as a Militia Man from said State of North Carolina and as he believes served a second term of three months, and as he understood at that time and as his recollection serves him now, that the said Thrower was honorably discharged. That said Thrower marched from the State of North Carolina, to the State of South Carolina, and from thence to the State of Georgia where he died.
