## Southern Campaign American Revolution Pension Statements & Rosters

Pension application of James Williams W6506 Pattey fn40VA
Transcribed by Will Graves 9/20/11

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

## State of Virginia, New Kent County, to wit

On this \_\_day of March 1834 personally appeared in open Court before Wm H. Macon, Rd. Graves, Beverly Crump, John A. Taylor, & Thos. K. Terrell the Court of said County now sitting James Williams a resident of said County and State aged Seventy years who being first duly sworn doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named Officers and served as herein stated according to the best of his recollection; that he entered the service as a militia man from the County of New Kent (the time of entering not recollected being then very young) under Captain George Baker of said County and served a tour of 3 months and was then discharged –

That he again entered the service as a volunteer under Captain John Bacon and was stationed at Providence Forge New Kent County Virginia, thence he was marched to the Long Bridge in said County where some of the Regular Troops were stationed, thence to Williamsburg where he remained some time, thence he was marched to York Town Virginia where he changed captains and was put under the command of Captain Waldergrove Clopton [Waldegrave Clopton] who was from the County of New Kent, thence he was marched to Newport News on the mouth of James River and after staying in and about that place sometime returned to York Town at which last named place his term of service having expired and his Captain having guit he returned home, this tour he served six months the precise time when he entered and when discharged he has no recollection he however recollects it was during what was called Arnold's [Benedict Arnold] invasion – he recollects among some of the officers under whom he served the names of General Nelson, Colonel Innis and Major Ragsdale – he has no documentary evidence not having any written discharge. One tour he was drafted from the militia the remainder of his service was as a volunteer – that he was in no battle – that he knows of no person living in the County except Edward Slater and John Breeding who knows of his having served in the Army and there affidavits accompany this his declaration.

To the Interrogatories directed by the War Department to be propounded to every applicant he answers –

That he was born in the year 1763 in the County of New Kent

That he has no record of his age the same having been destroyed

That he was born in New Kent County, that he has lived a part of his time in the City of Richmond Virginia and a part in New Kent and that he now lives in New Kent County.

That on one tour he served as a militia man – the balance of the time as a volunteer

That he has stated in his declaration the names of some of the Officers as well as he recollects.

That he never did receive a written discharge.

That he is known to Edward Slater and John Breeding who can testify as to his character for veracity and their belief of his services as a soldier of the Revolution and that Colonel William H Macon the presiding member of this Court will also certify as to his character and his belief of his services.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of any state.



And we Edward Slater & John Breeding residing in the same County and State do hereby certify that we are well acquainted with James Williams who has subscribed and sworn to said declaration that we believe him to the seventy years of age and that he is reputed & we know him to have been a soldier of the Revolution.

[fn p. 13: On September 13, 1843 in New Kent County Virginia, Pattey Williams, aged 78 years 11 months and 10 days made application for a Widow's pension under the 1838 act as the widow of James Williams, a pensioner of the United States for his service in the revolution at the rate of \$80 per annum under certificate number 23760; that she married him March 7th, 1784 and that he died September 29, 1840.

[fn p. 15: On September 13, 1843 in New Kent County Virginia, John Williams, son of the veteran and his widow, authenticated the family record. The images of the original record are posted on fn pp. 16-24 and read, in part, as follows:
