Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Tennessee, Wilson County

On this day personally appeared in open Court before the undersigned a Justices of the peace holding the Court for the County of Wilson now sitting at their September sessions A.D. 1832 Thomas C. Williams, resident of the said County of Wilson aged 79 years (there is no family record of his age but he has known from early life according to the account given by his parents that he was born on the 12th of April 1754 in the State of North Carolina in the County now known by the name of Warren) who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June the 7th A.D. 1832. That he first entered the service of the United States under the following named officers and served as herein Stated Viz. He volunteered as a minute man in the militia in Montgomery County in the State of North Carolina under Col. Drury Ledbetter the Colonel who commanded the militia of said County of Montgomery in the year 1779. Charles Jones acted as Major West Harris acted as Captain, General Rutherford [Griffith Rutherford] Commanded the Regiment to which he belonged. Col. Ledbetter's Company or Battalion were all mounted men and furnished their own horses the object of calling out the man into service of the company to which he belonged was for the purpose of subduing the Tories who were at that time very troublesome they were ordered from point to point whenever they were informed that the Tories were formed in bodies or were committing depredations on the Whigs. Deponent was engaged in this service for the space of nine months during which period he was engaged in a number of skirmishes with the Tories an engagement against the Tories that had embodied themselves to the number of 300 in Anson County in the State of North Carolina, in which the Tories were overcome and retreated after a considerable resistance besides a number of smaller engagements with smaller parties overtaken in the Woods and other places.

The second tour of service was rendered in the following manner. Deponent went on a visit to his wife's father's who resided in Warren County in the State of North Carolina where he remained for several months during his stay he was drafted for a three months tour in the militia which service he performed he marched to Halifax in North Carolina where he remained until the expiration of his term of service which happened shortly after the surrender of Cornwallis [Yorktown, October 19, 1781] in this service he was under the command of General Thomas Eaton who then resided in Warren County his acting Colonel was Colonel Brickle [William Brickell that Thomas Brickle was his Captain this service was performed in 1781 his whole service amounted to 13 months in the different tours – applicant moved from the State of North Carolina about 25 years ago and has resided the most of that time and still resides in Wilson

County – he has long since lost his discharges – he can prove by Thompson Clemmons¹ who was in the Army with him nine months of his service under Captain Harris & Col. Ledbetter the same nine months service he can likewise proved by Samuel C. Williams² and also his term of service of three months he hereby relinquishes every claim whatever to a pension except the present and his name is not on the pension Roll of any State in the United States.

Thompson Clemmons and Samuel Williams do hereby certify that they are both in the Revolutionary War with the above named Thomas Williams under Captain West Harris and in the Regiment commanded by Col. Ledbetter and General Rutherford and said Thomas Harris served the time of nine months as stated in his declaration. Williams likewise served with said Thomas Williams under Captain Brickle, Col. Brickle and General Eaton for three months the said Thomas served the same length of time making in all 12 months service witness Clemmons is now 81 years of age, Witness Samuel Williams is now 74 years of age applicant is a highly respectable person.

William Couples?], and that they were Married some time previous to the Revolutionary War.

[p 10: On November 15, 1837 in Wilson County Tennessee, Thomas Williams, son of Thomas C Williams, aged 47, gave testimony that the Bible record submitted by his mother of the birth of his parents children is in the handwriting of his father.

[Veteran was pensioned at the rate of \$47.50 per annum commencing March 4, 1831, for service as a private for 12 months, 3 in the infantry & 9 in the cavalry, all in the North Carolina militia. His widow was pensioned in a like amount.]
