Pension application of Elijah Williamson W6518 Sarah Williamson f66SC Transcribed by Will Graves rev'd 5/30/10 & 6/9/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of NC, Buncombe County: Superior Court of Law, April Term A. D. 1833

On this __ day of April 1833 personally appeared in open court before the honorable Judge of the Superior Court of Law for the County of Buncombe, now sitting, Elijah Williamson, a resident in said County of Buncombe, North Carolina aged Seventy eight or nine years, who being first duly sworn according to Law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th, 1832. That he entered the service of the United States under the following named officers and served as herein stated.

That he entered the service of the United States in the County of Ninety Six So. Ca. (now Laurens District) as a drafted militia man under Capt. John Rogers in the Regiment of Col. Williams [James Williams] for three months served along the then Indian frontier near Saluda River & was discharged at the end of three months, some time in the Spring of 1778 as well as he recollects. That he entered the service again in the summer of the same year under Capt. John Stephens [or Stephenson] as a drafted soldier for three months & served along the Indian line near Reedy River & was again discharged after having served three months. That he again entered the service in the Fall of 1780 or '81 as a volunteer under Capt. James Dillard for six months in Ninety Six District (now Laurens District) So. Ca. in the Regiment of Col. Levi Casey (a regiment of mounted horse men called Rangers) & served in various parts of the State of South Carolina against the Tories & Indians—and was discharged having remained in the service for some time after the six months had expired. That he has no documentary evidence of this service & that he knows of no persons whose testimony he can procure who can testify to his service except Calvin Williamson, Thomas Williamson, John Bagwell & James Dillard of Laurens District So. Ca. whose affidavits are hereunto annexed.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name in not on the pension roll of the agency of any State.

Sworn to & subscribed the day & year aforesaid

The following interrogatories were put by the court:

1st: When and in what year were you born?

Answer: in Bertie County North Carolina in the year 1754 or 1755.

2nd Have you any record of you age and if so, where is it?

Answer: I have no record of my age only know it from memory having been told by my parents. 3rd Where were you living when called into service? Where have you lived since the

Revolutionary War and where do you now live?

Answer: I was living when called into service in the District of Ninety Six South Carolina now Laurens District; that he removed to Rutherford County North Carolina (now Buncombe County) shortly after the revolution where he has lived ever since, except an absence of six months when he [was in] the state of Georgia and now lives at the same place in Buncombe County North Carolina.

4th How were you called into service; were you drafted; did you volunteer, or were you a substitute and if so for whom did you substitute?

Answer: I was first drafted for the term of three months and volunteered for six months afterwards.

5th State the names of some of the Regular Officers who were with the troops where you served, such Continental and Militia Regiments as you can recollect and the general circumstances of your service.

Answer: There were no regular officers with the troops where I served. I knew no officers except those of my own Regiment and served in serious parts of the state of South Carolina as set forth in the forewarning declaration.

6th Did you ever receive a discharge from the service; and if so by whom was it given; and what has become of it?

Answer: I never received a written discharge but was discharged verbally by the officers under whom I served.

7th State the names of persons to whom you are known in your present neighborhood, and who can testify to your character for veracity and good behavior and your services as a Soldier of the Revolution.

In sir: I am acquainted with Benjamin King, a clergyman, and General Brittain & William Smith. S/ Elijah Williamson, X his mark

South Carolina Laurens District: Personally appeared before me Calvin Williamson of the above named State & District & after being duly sworn on oath saith that Elijah Williamson of North Carolina Buncombe County rendered the following services in & for the cause of the United States, first entered Service as a drafted man three months, under Captain John Rodgers in South Carolina L. District, second Tour of Service under John Stephens Captain for three months both in the year 1778 as well as recollected, third tour volunteered six months or upwards under Captain James Dillard in the year 1781, as well as recollected, first Tour in Ninety Six District now called Lawrence near the line of the Cherokee nation of Indians Regiment commanded by Colonel Williams, Second Tour at a station on Reedy River near the Indian nation also attached to Colonel Williamses Regiment third Tour in various parts of the upper part of South Carolina troop of horse Regiment commanded by Colonel Levi Casey. Sworn to and subscribed before me February 19th, 1833.

Personally appeared James Dillard Senior³ Esquire (being an old and infirm person; and unable to attend in Court) Before me Robert Long Esquire one of the Justices of the Quorum in the district aforesaid and being duly sworn on his oath saith that Elijah Williamson volunteered under him (the said deponent) then a Captain in the Little River Regiment of Militia of South Carolina; in the latter part of the year 1781 & beginning of the year 1782 in the cause of Liberty; that to the best of his (this deponent's) recollection he must have served fully six months at the least; in the American cause; and further this deponent saith not.

[p 4: On January 14, 1845 in Henderson County North Carolina, Sarah Williamson, 81, filed for a widow's pension under the 1838 act stating that she is the widow of Elijah Williamson a pensioner of the United States for his services in the revolution at the rate of \$45 per annum; that


she married him in September 1782; that her husband died September 29, 1837; that they were married in Lawrence district [sic, Laurens District] in South Carolina; that she has no record proof of her marriage nor the ages of her children; that a record of said marriage together with the age of some of their oldest children was written into a Bible by her husband which he gave to some of their relatives who passed their house moving to the West; "She further states that the following is a list of the names of her Children together with their ages as near as she can recollect (namely) Kissiah Williamson eldest was born 7th January 1784, Rachel Williamson 29th September 1786, Rebecca Williamson the _ day of August 1788, John Williamson the 1st day of July 1790, Phelby Williamson the 28th day of February 1792, William, some time in April 1793, Sarah Williamson some time in March 1795, Stacy Williamson some time in March 1797, Melinda Williamson some time in August 1798, Ann Manervy the youngest Child on the 26th of June 1805."]

[p 17: On January 14, 1845 in Henderson County North Carolina, Rachail Posey [sic] testified that she is the daughter of Elijah and Sarah Williamson and lived with her parents and her brothers and sisters as set forth and her mother's application; that she was born September the 19th, 1785; and that she believes the facts set forth in her mother's application are true.]


