Pension application of Philip Wolfenbarger (Wolfenberger) W6575 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Ohio, Gallia County

This day personally appeared before me the subscriber Thomas Rodgers one of the Associate Judges of the Court of common pleas for the County of Gallia & State of Ohio Philip Wolfenbarger aged about 57 years and a resident of said County of Gallia, and being duly sworn according to law, doth upon his oath, make the following declaration, in order to obtain the provision of a late law of the United States, entitled an act to provide for certain persons engaged in the land & naval service of the United States in the Revolutionary War. That he the said Philip Wolfenbarger enlisted in Miller's Town in Shenandoah County in the foot service in Captain Wallan's [the War Department read this name as "Wallace"] Company, under Major Ridley [Thomas Ridley] of the Virginia line, the time of this enlistment he does not recollect, but the term of service was for 18 months, & that he was in the battle of Guilford [March 15, 1781], the said Major Riddle [sic] then & there commanding the Regiment in which he served. That about two months after this battle as well as he can recollect, he enlisted for "during the war" in the horse service, and first served in Captain Hughes [John Hughes'] company of Cavalry thence served under Captain Watts [John Watts] who took command of the same company. He well recollects Henry Bowyer was his first Lieutenant while he served under Captain Hughes & he thinks also while he served under Captain Watts; & that he continued to serve under Captain Watts until he was discharged at Winchester after peace took place – to which place the company was marched from South Carolina for the purpose of being mustered & discharged. That the company was marched to that place under the command of Lieutenant Bains. That the officer came up from Richmond to discharge the man whose name he does not recollect. That the company in which he served composed a part of Washington's [William Washington's] corps of Cavalry & that he served under said Washington in the Battle of the Cowpens [January 17, 1781], Eutaw Springs [September 8, 1781] & many skirmishes in Georgia, & was at the taking of & cutting to pieces of a body of Indians near Savannah that had attempted to [balance of line obliterated and illegible]. And that he has now no other evidence within his control whereby he can prove said service & that he is now in such reduced circumstances as absolutely to stand in need of the assistance of his country for his support & that owing to the cold and fatigues he underwent while in service he is so much crippled in one of his legs, as often to prevent him from labor, which is his only support.

This is to certify that the above named Philip Wolfenbarger this day before me made oath to the truth of the foregoing declaration & in my presence subscribed the same & that from his character for truth & honesty, as well as from the facts contained in his declaration, I am well satisfied, that he served the United States in the revolutionary war as therein stated, And I further certify, that from my personal knowledge of the affiant, as well as from the testimony of his neighbors, I am well convinced that he is both infirm, & in reduced & needy circumstances, &

absolutely stands in need of the assistance of his country for his support.

The said, Philip Wilson Barber, in further proof of his said services on his oath declares that at the time he enlisted for during the war, he was enrolled in said Hughes Company, that company formed a part of William White's [sic, Anthony Walton White's] Regiment of Horse or Cavalry which was of the Virginia line – sometime after his enlistment, the said White's Regiment became so reduced, that it was consolidated, & this deponent was transferred to Colonel Washington's Regiment, as is set forth in his said declaration.

State of Ohio Gallia County SS – Court of Common Pleas

On this 1st day of August 1820, personally appeared in Open Court, being a Court of record for said County, Philip Wolfenbarger, age 57 years & 11 months – resident of said County & being first duly sworn according to law doth on his oath declare that he served in the revolutionary war as follows,

That he enlisted out of the foot service (where he was doing duty as a soldier for a Term of 18 months) into Captain Hughes' Company of Cavalry for during the War, shortly after the battle of Gilford [Guilford Court House, March 15, 1781] in which he was engaged in the foot service, and continued to serve in said Company of Cavalry, the latter part of which time it was commanded by Captain Watts, – The said Company serving first in Colonel White's Regiment, and afterwards in Washington's Troop or Regiment, in which he was serving at the close of the war at which time he received an honorable discharge, all of which will more fully appear & by additional testimony in his former declaration on which he has received a pension certificate numbered 16790.

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed:

And I the said Philip Wolfenbarger to furthermore solemnly swear that I am indebted to Robert Worth & Company \$21 on the note, I gave Samuel W. Blaff \$15, to Andrew Morrison \$30, to J. Sams about \$6, to David D. Varian \$10 – and several other small demands the whole amounting to above \$100, on most of which there are judgments to be satisfied out of the property entered in the above schedule, which will not sell for a sum of money that will discharge my debts & that I have no other means to discharged them. That I am a Common labor by occupation, and that my family consists of a wife – a grandchild, a girl of about 7 years, & a boy of about 12 years. That by reason of my suffering while in the service of the United States 1 of my legs is so injured with the cramp as to often prevent me from any kind of exercise.

[Veteran died in Pike County, Ohio October 1, 1852; he married Catharine Cooper on May 23, 1791 in Greenbrier County, Virginia; she applied [p 31] for a widow's pension at age 78 on October 19, 1852 when she was a resident of Pike County, Ohio; she died in Pike County on February 14, 1855; Philip and Catharine had only one child, Elizabeth, born February 23, 1795; married Abraham Taylor, born May 8, 1787, died about 1850; the names and birth dates of Abraham and Elizabeth Taylor's 9 children are listed in the files, and includes the married names of their female children. Phillip Woolfinburger a Soldier 1st Reg't. Dragoons has leave of Absence with his horse, armes & accourrements till the 20 July, then to repair to the rendesvous of the Reg't. or sooner if call'd for by Commanding Officer Rob't. Morrow [Robert Morrow BLWt1508-300] Capt. LD June 25 1783

I do certify that Phillip wolfinburger inlisted to serve as a sold'r. for the war in 1st Reg't. of Dragoons on the 1st day of april 1781. June 30 1783 G Hite [George Hite W5105] Lieut 1st R. L.D. Nov. 1st 84/ pass'd S Hawes Com'r. Copy/ Philip Southall

For Value Rec'd. I do Assign to Wm. Reynolds the full ballance pay gratuety & bounty Land due me as a sold'r. cavalry.
