## Southern Campaign American Revolution Pension Statements & Rosters

Pension Application of John Dugger W7062 Frances Dugger VA
Transcribed and annotated by C. Leon Harris.

State of Tennessee } On this 21<sup>st</sup> day of August 1832 personally appeared in open Court, Sumner County } before the Justices of the County Court of Sumner now sitting, John Dugger, a resident in said County and Stated aged eighty four years, who being duly sworn according to law, doth on his oath make the following declaration, in order to obtain the benefit of the act of Congress passed June 7<sup>th</sup> 1832

Some time during the Revolutionary War Applicant was drafted as a militia man for the term of three months, under Capt Peterson Gooden – was attached to Col Banisters [John Banister's] Regiment his General is not recollected – was marched to Smithfield Virginia there remained some time – after serving six weeks he was discharged his discharge has been lost. Something like a year after, applicant was again drafted as a militia man under Capt Dickson and thinks was attached to Col Edward Pigrims [sic: Edward Pegram's] regiment served six or seven weeks and was discharged. During this term he was marched to Petersburg Virginia. Applicant a few weeks before Christmas, in the year 1781 [sic] volunteered under Capt William Lucas, and was attached to Col Robert Mumford [sic: Robert Munford] regement – was marched to Hillsboro [sic: Hillsborough NC] there joined the North carolina militia – then to High Rock ford on Haw river there joined Genl Green [sic: Nathanael Greene] – then marched to meet Cornwallis, engaged him at Guilford Courthouse [15 Mar 1781] – was whipp[ed] applicant remained with Green after the battle about two weeks and was discharged after having served something more than three months. The above is all the service performed by applicant. He does not know at present of any person living whos testimony he can procure by whom he can prove his services. The officers named that is Captains & Colonels lived in Virginia.

Applicant was born in Surry County Virgini in 1749. There he lived until he was about eighteen – he then moved to Brunswick County Virginia – he afterwards lived in different Countys He lived in Dunwooddy [sic: Dinwiddie] County Virginia when he served as a militia man – he lived in Brunswick when he volunteered. Seven or eight years after the Revolution he moved to Orange County North Carolina lived there about eight years. Applicant left North Carolina about thirty four or five years since and come to Sumner County State of Tennessee where he has live ever since. Applicant has no Documentary evidence by which he can establish his claim.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the Pension Roll of the agency of any State. Sworn and Subscribed, the day and year above named.

## NOTE:

On 27 April 1838 Frances Dugger, 88, applied for a pension stating that she married John Dugger on 4 Nov 1771, and he died on 23 March 1834. Robert Taylor and William Brice certified the application. A record of the marriage was sought unsuccessfully in Brunswick County.

On 12 Dec 1840 Benjamin Taylor, 59, stated that he was the brother-in-law of Leonard Dugger, the second child of John and Frances Dugger, and who died in 1817. On 3 July 1840 Flood Dugger, seventh child of John and Frances Dugger, stated that their original family record was destroyed by the burning of the house of an elder brother. Benjamin Taylor stated that the family record transcribed below was a copy taken from a record kept by John and Frances Dugger. The record is difficult to read because of fading and poor penmanship.

William Ferguson Dugger a son of Jarrot and polly Dugg was born 4 of Apreil 1817

Jarrot Dugger son of Leonard Dugger and Rhodia his wife was Born february 8th Day 1792

Wesley Dugger son of the [one or two illegible words] was Born April 30 1793

polly Dugger the Daughter of the [illegible word] two was Born December 14 Day 1795

Betsey and John Dugger twins of the above mention Was Born [illegible] 14th Day 1797

Nancy Dugger the Daughter of [one or two illegible words] Dugger and Elizabeth his wife was Born September the  $5^{\text{th}}$  1801

Leonard D Johnson son of John and Nancy Johnson was born September 24<sup>th</sup> Day in the year of our Lord 1819

I Leonard Dugger was married to Elizabeth Taylor my present wife in the Begining of the year 1801 January 12<sup>th</sup>

Nancy Dugger daughter of leonard Dugger was maried to John Johnson August the 27<sup>th</sup> 1818 August 24 1820 John C Dugger was married to Molly McAdam

Jarrot Dugger son of Leonard Dugger was married to polly his wife the twenty fifth of August 1811 Wesley Dugger the son of leonard Dugger was married to Lotty [or Letty] his wife Jully the 15 in the year of our lord 1816

Nancy Dugger daughter of Leonard Dugger was married August the 27<sup>th</sup> 1818

Died the 10 Day of July 1820 Nancy Johnson the wife of John Johnson the Daughter of Leonard and Elizabeth Dugger
