## Southern Campaign American Revolution Pension Statements & Rosters

Pension application of Joel Yarbrough (Yarborough) W7382 Agness fn33VA
Transcribed by Will Graves 7/14/11

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

This day Joel Yarbrough appeared in Court and made upon oath the following Declaration to wit That he is seventy-one years old a native of Caroline County & that he enlisted in the regular service of the Army of the United States of America in the year 1776 as a common soldier under the command of Captain George Stubblefield under whom he served in the 5th Virginia Regiment commanded by Colonel Richard Anderson attached to General Muhlenburgs [Peter Muhlenberg's] Brigade until the year 78. That his enlistment he believes was in the month of December & his discharge in the month of January 1778 making more than two years constant & faithful service in the revolutionary Army of the Continental establishment. That he is period of enlistment having expired he was honorably discharged & in a short time thereafter was drafted & sent to the South where he remained about six months till Gates defeat at which he was present. That he is old & of course infirm and unable to support himself & his wife also advanced in years. That he has lost his discharge or mislaid it or probably has worn it out nearly fifty years having elapsed since given to him.

This day Rich'd Bridges [Richard Bridges] appeared in Court & made oath that Joel Yarbrough enlisted in 1776 under Captain George Stubblefield and that he saw him in the Regiment at little York Virginia in that year & in the following year was with him at the battle of Germantown. That he believes said it Yarbrough was a faithful soldier during his time of service & having always believed that he was honorably discharged.

[There is no indication that Bridges signed this affidavit.]

At a Court of monthly session held for Caroline County at the Courthouse on Monday the 11th of May 1818 This day Joel Yarbrough a revolutionary soldier came into Court and made oath to this his declaration, and Richard Bridges also made oath that the said declaration contained the truth and the Court being satisfied that he stands in need of Public support the same is ordered to be certified.

District of Virginia, Caroline County –Sct.

On this \_\_day of August 1820 personally appeared in open court, being a court of record, for the County aforesaid, Joel Yarbrough aged about seventy-four years, resident in said County, who being first duly sworn according to law, doth on his oath declare that he served in the Revolutionary War, as follows: served two years in northern Army under Colonel Parker in the 5th Virginia Regiment was in Battle of Germantown, Princeton and Brandywine, served

afterwards in the southern Army as stated in declaration of the 11th day of May 1818 on which he received a pension certificate No.\_\_

And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. Have a dower right in one hundred acres Land and one cow family – wife and a daughter named Lucy aged about twenty-seven years, son named Henry aged about eight years

Sworn to and declared on the 14th day of August 1820 before the court of the County aforesaid.

[fn p. 12: On May 14, 1839 in Caroline County Virginia, Agness Yarborough, 74, filed for a Widow's pension under the 1836 act stating that she is the widow of the late Joel Yarborough, a pensioner of the United States for his service in the revolution; that she married him February 1, 1783 and that her husband died December 12th, 1827; and that she remains his widow. She signed her application with her mark.]

[fn p. 13: Lucy Southworth, 76, gave a supporting affidavit in which she said she has known the widow since their infancy; that she was present at the wedding of the veteran and to the claimant and that the veteran died December 12, 1827.]

[fn p. 18: On December 6, 1839 in Caroline County Virginia, the widow filed a claim under the 1838 act for a widow's pension.]

[Veteran was pensioned at the rate of \$8 per month commencing May 11, 1818 for two-year service as a private in the Virginia Continental line. Veteran's widow was pensioned at the rate of \$80 per annum commencing March 4th, 1843.]
