

## Southern Campaign American Revolution Pension Statements & Rosters

Pension application of William Steelman W8888<sup>1</sup> Catharine Hawkins<sup>2</sup> fn64+10NC

State of North Carolina Rowan County

On this 16th day of May 1834 personally appeared before me an acting Justice of the peace for the County of Rowan Williams Steelman a resident of the County aforesaid aged 84 years last January who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers and served as hereinafter stated.

He entered the service as a volunteer in the County of Rowan North Carolina where he then resided for the term of 3 months in the year 1779 under Captain Samuel Mosby. From the County of Rowan he marched to the Indian Nation where his Company burnt three of the Indian Towns leaving three remaining, in one of these Towns they found the scalps of nine white man. The Indians fled before them. Where upon the expiration of his term he returned home. He then volunteered for the term of twelve months in Rowan County under one Elias Langham a recruiting officer for Captain William Armstrong ["Pretty Billy" Armstong]. This was in February 1782 as the enclosed certificate of said Langham will show. From Rowan he marched to Bacon's Bridge near Charleston in South Carolina where he was stationed. While stationed here he often went out in scouting parties against the British in which his party was sometimes successful and sometimes defeated.

These skirmishes took place generally of a night. He recollects that near where they were stationed there was a place called by them the quarter house, for the possession of which different contests took place between them and the British. He thinks this house was first taken by the Americans from the British and after being retained by the British was again retaken by the Americans. While stationed here as well as he now recollects his time expired and all his Company was discharged. Immediately after the he and 4 others of his Company to which William Bates, Mathias Bates, Samuel Club & Samuel Love then volunteered at this place to guard their Major who was by the name of McCree [sic, Griffith John McRae] to Wilmington in North Carolina they being selected by him for that purpose. He thinks McRae was engaged principally about Wilmington at that time in having clothes made for the soldiers. During this

term he thinks he remained with McRae about one month, making in all 16 months for which he has never received one cent.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any state.

He has no documentary evidence of his service except that herewith enclosed and he knows of no one by whom he can prove his service except Thomas Cain.

There is no clergyman living in his neighborhood whose testimony he can procure.

He further swears that he is unable to attend Court.

He received a discharge from Major McRae which is lost also one from Samuel Mosby which is enclosed. He further swears that from his extreme [old age] and consequent loss of memory he is unable to give a minute and particular account of his service. To the

Interrogatories required by the War Department to be propounded to him he answers

To 1<sup>st</sup> Question: Answer: in Kent County Delaware in the year 1750

To 2<sup>nd</sup> do Answer: I have none

To 3<sup>rd</sup> do Answer in Rowan County where I have lived ever since

To 4<sup>th</sup> do Answer I volunteered

To 5<sup>th</sup> do I recollect none at this time


To 6<sup>th</sup> do I received a discharge from Major McRae [indecipherable word written over] is lost




[Frederick May & Thomas Cain gave the East Anders supporting affidavit and attest to the bodily infirmity of the veteran. In addition, Thomas Cain gave a separate affidavit saying that he well knows that the veteran was in service for 12 months because he looked after the veterans business and his family during his absence.]

[fn p. 6 of first file: On May 29, 1855 in Davie County North Carolina, Catharine Hawkins, 69, filed for a widow's pension under the 1853 act stating that she is the widow of William Steelman a pensioner of the United States for his service in the revolution; that she married him July 4th, 1823 in Rowan County North Carolina; that they were married by one Joseph Pickler, a licensed minister of the gospel; that her name prior to her marriage was Catherine Cain; that her husband died in Rowan County March 7th, 1837; that she afterwards married William Hawkins who died in the County of Davie (once Rowan County) North Carolina September 20, 1852 and that she remains a widow.]

[fn p. 9: marriage bond issued in Rowan County North Carolina on July 4, 1823, issued to William Steelman and Hiram Cook to secure the marriage of William Steelman to Catharine Cain.]

[Steelman was pensioned at the rate of \$53.33 per annum commencing March 4th, 1831, for 16 months service as a private in the North Carolina Continental line and militia. His widow, who married William Hawkins, was pensioned at the rate of \$53.53 per annum.]
