Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

[fn p. 17: On June 2, 1845 in Edgefield District South Carolina, Elizabeth Williams, 77 last April, filed for a widow's pension under the 1838 act stating that she is the widow of William Williams who it will appear by his annexed pension certificate was a soldier of the war of the revolution; that she married him on the 26 or 27th of March 1792 or 1793 by the Reverend Benjamin Harry a Baptist Minister; that she has no documentary evidence of her marriage; that her husband died April 4th, 1838. She signed her application with her mark.]
