[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

South Carolina Union District: to wit

On this 6th day of October 1832 personally appeared in open Court before the Judge of the Court of Common Pleas & Sessions now sitting for said District Daniel Holder a resident of Union District aged Seventy four years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress June 7th 1832. That he entered the service of the United States under the following named officers and served as herein named –

In the last of June 1780, I entered the service under Captain Isaac Clemons [Isaac Clement] in Pittsylvania County Virginia & marched then to Hillsboro North Carolina, then to Pedee [River] under Colonel Falkner [Ralph Falkner or Faulkner] & Major Canaway [Henry Conway] & under the Command of General Stevens [Edward Stevens]. Thence I marched to Rugeley's Mill & joined General Gates [Horatio Gates] — was in the engagement at Gates defeat [Battle of Camden, August 15-16, 1780] near Camden — and after the defeat retreated to Pedee & then to Hillsboro where I got leave to go home in September 1780: — I then Joined the service again about the 20th of October in the same year & under Captain Peter May & General Stevens and remained until first February 1781, when I was discharged (as my discharge will show) during this time I was Stationed at Hillsboro to guard the British & Tories prisoners taken at Ferguson's defeat [Battle of Kings Mountain, October 7, 1780]. I again joined the Service under Captain Spencer Shelton on the 11th May 1781 — & continued until the 19 July 1781 when I was discharged by Captain James Turner by order of Major Alexander Rose during this Tour we commenced a March for Ninety Six but being sick was left in the Hospital at Charlotte North Carolina at which place I was discharged.

I have no other documentary evidence of my Services but two discharges herewith filed, I know of no person living that served with me during the Revolutionary War to whom I can refer

To the Interrogatories to me propounded by the Court I answer 1 & 2 - I was born in Fauquier County Virginia in the month of April 1758. I have no record of my age; 3. See within, I have lived in Union District about forty-four or five years previous in North Carolina & Virginia after the Revolutionary War. 4^{th} . I substituted the first Tour for James Lawless – Second Tour volunteered & Third Drafted – 5. See within – 6. I received two Discharges, one signed by Colonel John Gunby & the other by Captain James Turner herewith submitted. 7. I

refer to the Reverend Willis Walker & William Mitchell to prove my Character for truth and moral deportment, I do hereby relinquish any Claim whatever to a pension or annuity except the present, and do declare that my name is not on the pension Roll of the agency of any State. Sworn to & subscribed the day & year first aforesaid



[p 7: On March 19, 1845 in Union District South Carolina, Ruth Holder, 89, filed for a widow's pension under the 1838 act stating that she is the widow of Daniel Holder, a revolutionary war pensioner; that she was married to him in 1787 in January but she cannot remember distinctly the precise day; that the ceremony was performed by Robert McLain Esquire of Randolph County North Carolina; that her maiden name was Welborn; that she has an old record of her marriage that reads as follows: "Daniel & Ruth Holder was married 1787"; she also has a slip of paper on which is recorded the births of her children, their first born being Elizabeth Holder born October the 30th 1787; that her husband died April 23, 1843; and that she remains his widow. She signed her application with her mark.]

[Veteran was pensioned at the rate of \$26.12 per annum commencing March 4th, 1831, for service as a private for 7 months and 25 days in the Virginia militia. His widow was pensioned in a like amount.]
