Pension application of Robert Kinkade (Kincaid) W9102 Mary Kinkade 39PA/VA Transcribed by Will Graves 12/2/13; rev'd 7/11/20

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky Hardin Circuit | Sct. June Term 1820

Ordered that the following declaration affidavit and schedule be admitted to record having been sworn to in open Court

Original Claim

District of Kentucky Hardin County SS

on this 16th day of June 1820 personally appeared in open Court being a Court of record for the County and district aforesaid Robert Kinkade aged seventy eight years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the acts of Congress of the 18th day of March 1818 and the 1st day of May 1820 that he the said Robert Kinkade enlisted first for the term of one year under Captain George Gibson and formed the first Virginia Regiment then I enlisted for three years under Captain Samuel Crump¹ in Read's [perhaps Col. Isaac Read's] Regiment I was detached into Colonel Daniel Morgan's rifle Corps in the year 1777 in the State of Virginia and was also detached out of that company into Captain Gabriel Long's company and served in that Company until I was discharged which was about August 1779 then at General George Washington's request I took the command of a small party to scout the line in the York State at Fort Montgomery where he was discharged from the said service in 1779 in the State of New Jersey by Peter Meaklenburg [Peter Muhlenberg] Brigadier General in the year 1780 I went to see on board of the state ship *Hyderally*² commanded by Joshua Barney³ I was out with Commodore Barney until peace was

³ BARNEY, JOSHUA MD/(P/A) First Lieutenant, Continental Navy Commander, Pennsylvania Privateers Joshua Barney was born on 6 July 1759, one of fourteen children of William and Frances Barney of Patapsco Neck, Maryland. [Smith, Marines, 430] He was [Acting Second Lieutenant] on the Continental Navy Schooner *Wasp* from about 7 April 1776 to about 10 May 1776, when he was ordered aboard the Continental Navy Sloop *Sachem* (Captan ISAIAH ROBINSON) at Philadelphia to oversee her outfit. Barney was commissioned as First Lieutenant sometime in June 1776. He was aboard the *Sachem* during her action with the British Privateer Brig *Three Friends* on 12 August 1776. On 20 September 1776 he transferred to the Continental Navy Brig *Andrew Doria* with Captain Robinson. Barney was ranked 13th on the Lieutenant's List of 12 October 1776. [xx] Barney was later captured and

spent five months on a British prison ship in New York harbor before being exchanged. [NOAR, 16] On 26 July 1780 a letter from Joshua Barney was read in Congress, reviewing his career in the Continental Navy and requesting that his rank be fixed and his pay determined. Barney's request was, in essence, not to be reduced in pay by being transferred from a vessel of over twenty guns to one of less than twenty guns (there being a pay differential). The letter was referred to the Board of Admiralty. [NRAR, 153] The Board of Admiralty reported on 1 August 1780, recommending that any officer serving on a ship of war of twenty guns or more not be reduced in pay by reason of service on a smaller boat. Congress accepted this report on 7 August. [NRAR, 154] After being captured and exchanged a second time he was commissioned as commander of the Maryland Privateer BrigPonoma. He was captured a third time by HM Frigate Rosebud. On 16 January 1781 he was imprisoned in Mill Prison. Barney escaped, was recaptured, and escaped again on 18 May 1781. [NOAR, 16] On 2 April 1782 Barney was appointed to command the famous Pennsylvania Privateer Ship Hyder Ally, sixteen guns and 100 men. [NRAR, 348] On 2 April 1782, in a notable fight, he captured the British ship General Monk. [NOAR, 16] On 27 April 1782, Barney was appointed as commander of the Pennsylvania Privateer Ship [unknown], with eighteen guns and a crew of 120 men. [NRAR, 227] The General Monkwas taken into the Continental Navy as the General Washington, with Barney as lieutenant commanding. [NOAR, 16] He remained with her until she was sold out of service in 1784. On 6 March 1784, in a letter to Thomas Mifflin, President of the Continental Congress, Barney requested promotion from Lieutenant to Captain. [p 7: On October 16, 1839 in Hardin County Kentucky, Mary Kincaid [sic], aged 71, made application for a widow's pension under the 1838 act stating that she is the widow of Robert Kincaid [sic], a soldier & officer in the Revolutionary War; that her husband's application for a pension was deposited in the pension office by the Honorable Benjamin Hardin in the year 1819 or 1820; but her husband being unwilling to take the oath the law required that he was not worth more than a certain amount of property, he was never granted a pension; that she married him December 2, 1784 in Washington County Pennsylvania; that they were married by the Reverend Matthew Henderson; that her husband died January 31, 1832; that she knows of no record of her marriage or the ages of her children nor does she know of any living person who was at her wedding; that her oldest child Mary Ann is 53 years old on October 28; that her next oldest child Isabella was born January 17th 1789 &c &c.

[p 8: On October 16, 1839 in Hardin County Kentucky, James Kinkade, son of Robert and Mary Kinkade gave testimony in support of his mother's claim for a pension; he states that he well recollects seeing depositions of John McCandless⁷ and John Howe in support of his father's application for a pension in the year 1819 or 1820; that he has no doubt that his parents were lawfully married; that their eldest child is now 53 years of age; that they raised a large family of children.

⁶ The application is a copy certified by the Hardin County clerk. Consequently, the signatures are not those of veteran or the supporting witnesses. Perhaps the original of the claim is still among the documents in the Hardin County, KY, clerk's office or at the Kentucky Department for Libraries and Archives. It is also possible that the original claim, having been sent to Congressman Benjamin Hardin in Washington, might have ended up in either his personal files or those of Congress.

[p 5: On May 29, 1854 in Hardin County Kentucky, James Kinkade, 53, a resident of Hardin County and son of Robert Kinkade who died in said County on January 31, 1832 filed a claim for the pension due his mother Mary Kinkade who died in Hardin County on January 14, 1844 leaving the following children alive at the time of her death:

that all of his mother surviving children are above the age of 21; that his mother applied for a widow's pension but it was rejected for some reason unknown to him; that he has been appointed the administrator of his mother's estate; that he appoints James G Austin of Washington DC as his attorney to pursue the claim of his mother's estate.

[Veteran was pensioned at the rate of \$120 per annum commencing March 4th, 1831 and ending January 31st, 1832 (the date of his death) based on his service for 2 years as a Sergeant in the Virginia Continental Infantry. Veteran's widow was pensioned at the rate of \$120 per annum commencing March 4th, 1836, for her husband service for 2 years as a Sergeant in the Virginia Continental line.]

[Facts in file: In a letter dated July 19, 1921 from the Bureau of pensions in response to an inquiry regarding this veteran's records, it is noted that his daughter Mary Ann was born October 28, 1786 and married John Veech; according to the claim made by her brother, she is not listed as having survived her mother.]

This day Robert Kinkade personally appeared before me Samuel Martin a Justice of the Peace for the County aforesaid and made oath that he enlisted in Virginia in the year 1776 for three years in Captain Samuel Crump's Company in the First Virginia Regiment on the Continental establishment commanded by Colonel Read and that Part of the time he rendered service under Colonel Morgan in William Henderson's Company but when he was discharged he was in Captain Gabriel Long's company commanded by Colonel Ball and that he was appointed Sergeant when he first Enlisted and was discharged Sergeant and that he served out his time for which he Enlisted and was honorably Discharged in New Jersey by General Muhlenberg [Peter Muhlenberg] – and that in the year 1780 he Enlisted for during the war in the Marine service under Captain Joshua Barney who commanded the vessel called Highder neligh [*Hyder Ally*]

until they took the General Munk [*General Monk*]⁹ and afterwards commanded the General Munk and that he served in said vessel in the Marine service of the United States until the close of the war in the year 1783 at which time he was honorably Discharged at Philadelphia in Pennsylvania by Captain Robert Patten and through the course of time he has lost his discharge and he never has received his land warrant for service.

This day John Howe personally appeared before me Samuel Martin a Justice of the peace for the County aforesaid and made oath that he has long been acquainted with the above Robert Kinkade who has subscribed to the foregoing declaration and he well knows that he is the identical person who represents himself to be and that he knew him to be a Sergeant in said service as with respect to his three years service on land and that he left the Army in 1779 after the expiration of three years.
