## Southern Campaigns American Revolution Pension Statements & Rosters

Pension application of Daniel McJunkin W9190 Transcribed by Will Graves Jane McJunkin f33SC rev'd 3/22/09 & 11/9/16 & 11/4/21

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina, Greenville District: Court of General Sessions and Common Pleas, Fall Term 1848

On this 9<sup>th</sup> day of November 1848 personally appeared before the Court of General Sessions & Common Pleas now opened and held at the Court House in Greenville for the District of Greenville & State aforesaid, Joseph McJunkin, a son of the late Daniel McJunkin deceased and a resident of said District aged 64 years, who being first duly sworn according to Law doth, on his oath, make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed the 4<sup>th</sup> of July 1836, granting Pensions to certain widows of Revolutionary Soldiers. That this declarant the aforesaid Joseph McJunkin in the behalf of himself and the other heirs of the aforesaid Daniel McJunkin deceased states that the said Daniel McJunkin was a private soldier in the Army of the Revolution as the heirs do understand and as such he served the United States against the common Enemy under the following officers, viz.: Captains John McCool, <sup>1</sup> Joseph Hughes, <sup>2</sup> Benjamin Jolly, Pearson and his brother, Captain Joseph McJunkin,<sup>3</sup> all of whom belonged to Colonels Thomas [John Thomas] and Brandon's [Thomas Brandon's] Regiments of the South Carolina Militia. That during the Revolution the said Daniel McJunkin lived in a district called Ninety Six, but now Union, and was generally in the service from the early part of the War until Peace was made, during which time he was in several engagements with the Enemy, viz.: at the Battles of Briar Creek [March 3, 1779], Cowpens [January 17, 1781], Blackstocks [November 20, 1780], Kings Mountain [October 7, 1780]<sup>7</sup> & Fair Forest [March 1781]<sup>8</sup> in which latter engagement he was severely wounded, and that on account of his said wound he was placed on the Invalid Pension roll of the State soon after the close of the War and was allowed a Pension for life and that after his death in 1825, his widow Jane was also pensioned by the State as the widow of a Revolutionary Soldier. This declarant also states that his knowledge of his Father's, the aforesaid Daniel McJunkin's, Revolutionary services is traditional and that to give a detailed account of his several tours of duty during the Revolution he cannot but that he has always understood and believes that with the exception of some five months that he was imprisoned by the Enemy in Camden Jail he was

during the latter part of the War constantly in the Army under some of the above named Officers, that his Father the said Daniel McJunkin was a son of Samuel McJunkin and a brother of Captain & Major Joseph McJunkin, all of whom resided during the Revolution in the aforesaid District of 96.

He further declares that the said Daniel McJunkin was married in the early part of the year 1781 or 1782 to Jane Chasney [sic, Jane Chesney?], and as husband and wife they lived together till the death of the said Daniel McJunkin which took place on the 20<sup>th</sup> March, 1825, and that his widow the said Jane departed this life on the 21<sup>st</sup> day of August 1841 not having intermarried after the death of her said husband leaving surviving the following Eight Children viz.: Joseph McJunkin, Elizabeth Steward, John McJunkin, Samuel McJunkin, Margaret Pearson, Daniel McJunkin, James McJunkin and George McJunkin, who are the only surviving children of the aforesaid James McJunkin deceased living in this Country, or known to be living and all of lawful ages.

[Veteran's widow's heirs were awarded a grant at the rate of \$62.22 per annum commencing March 4<sup>th</sup>, 1831 and ending August 21, 1841 in lieu of the pension due the widow had she applied for her pension during her lifetime. The amount of the pension was based on the veteran's service in the South Carolina Militia as a private for 18 months and 20 days.]



The Petition of the undersigned Humbly Sheweth that she is the widow of the late Daniel McJunkin Deceased, who was a pensioner of the State in the Sum of sixty dollars per annum. That she was married to the said Daniel McJunkin in the time of the Revolutionary War & that she remained the wife of the said Daniel until his death, which happened on the 20<sup>th</sup> of March 1825, and that she suffered in common with him the D. McJunkin all the privations, Losses, Crosses and distresses that were incident to or Occasioned by the Revolutionary War, and that she did not at any time during the war willingly aid or assist the Common Enemy of our Country;

and whereas she is now old infirm and distressed by disease, and in indigent circumstances, humbly prays your Honorable Body that she may be allowed to draw the moiety of the Arrearages of her Late Husband pension up to this date, and that she may be allowed a Pension during the few remaining years that she may remain in this life, and further saying that she is not at this time, nor never has been a pensioner on the United States and as in duty bound she will ever pray &c
