[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Maryland City of Baltimore SS

On this Twenty third day of November 1837, Before me, the Subscriber, one of the associate Judges of Baltimore City Court, Personally appeared Elizabeth Amos of the City of Baltimore aforesaid, aged 86 years, who having first duly affirmed according to law, doth on her affirmation make the following declaration, in order to obtain the benefit of the provision made by the acts of Congress passed June 4, 1836, and March 3, 1837: That she is the widow of Thomas B. Hugo (or Hugon) who was a Lieutenant and Captain in the 5th regiment of the Maryland line of the Continental Army in the War of the Revolution; He being appointed Lieutenant December 10th, 1776, and promoted to be a Captain June 1st, 1781: and she believes he continued in the Service until the close of the War. She further declares that she was married to the said Thomas B. Hugo (or Hugon) in the year 1778, at Wilmington in the State of Delaware: That her husband the aforesaid Thomas B. Hugo (or Hugon) died on the 29th of July 1798; And that she afterwards intermarried with William Amos, who died in December 1832: That she hath not married again Since the death of said William Amos: That she was a widow on the 4 July 1836 and still remains a Widow, as will more fully appear by reference to the proof hereto annexed.

[p 6: Thomas Morgan gave a supporting affidavit in which he stated he knew both Captain Thomas B. Hugo and Elizabeth Hugo; that they were reputed to be man and wife and was never doubted that their marriage was legal; That the veteran died on the date stated by his widow; That she subsequently married William Amos who died in December 1832.

No Papers The reason there are no surviving papers relating to this bounty land claim is that the offices of the War Department along with the papers filed there were destroyed by fire in 1800 and all pension and bounty land records predating that fire were destroyed. Further, pension and bounty land papers generated between the fire of 1800 and 1814 were lost when the British burned Washington DC on August 14, 1814.

I hereby Certify, that it appears by the Muster rolls of the Revolution remaining in this Office, that Thomas B Hugon, – was appointed a 2nd Lieutenant, in Captain Johnson's Company of the 5th Maryland Regiment, on the 10th day of December, 1776, was promoted to the Rank of 1st Lieutenant, on the 1st day of May 1780, – and on the 1st of June, 1781, was promoted to the rank of Captain, – And I further Certify that by a pay roll kept by John Hamilton, Agent for the Maryland Line, and also remaining in this office, it appears, That Captain Thomas B. Hugon, received pay up to the 1st day of January 1783 and Commutation, amounting to \$2360, – total amount \$2968.35
