[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina

On this 10th day of October 1819, before me the subscriber one of the Judges of the Court of Equity & of the Court of Appeals for the said State, personally appeared Ripley Copland, aged about fifty-eight years, resident in the district of Sumter and the said State, who being by me first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "An Act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War,"

That he the said Ripley Copland enlisted for the term of three years in the year 1777 in Chatham County in the State of North Carolina in the company commanded by Captain Matthew Ramsay, of the 9th Regiment commanded by Colonel Maburn [sic, Mebane] in the line of said State; that he was afterwards, at the Valley Forge in Pennsylvania, transferred to the first Regiment in the same line, & shortly afterwards was drawn as one of a light infantry company commanded by Captain Bowman, which was attached to a Corps under the command of General Wayne; that he was afterwards again restored to the first Regiment aforesaid then commanded by Colonel Clark which was ordered to Charleston South Carolina during the siege thereof, and that his time of service having been expired he was there discharged by Colonel Clark; that he was in the battles of Monmouth & Stony Point, & in various skirmishes; that he is in reduced circumstances and stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said services except the papers hereto annexed.

State of South Carolina Darlington District: SS: Personally appeared James Kilgore before me Albert Fort one of the Justices of the Quorum for said District who being duly sworn on the Holy Evangelist of Almighty God, who saith, that Ripley Copeland served as a Soldier in the time of the Siege Before Charleston surrendered to the British – this deponent saith Before the Surrender of Charleston, the said Ripley Copeland was discharged from the service of the United States. This deponent further saith that he was a Continental Soldier at the same time. Sworn to before me this 25th day of September in the year of our Lord 1819

State of South Carolina Chesterfield District: This is to certify that Nicholas Copeland Senior appeared before me one of the Justices in and for said District and certifieth [sic] that he was knowing to a certain man going to the regular service in the old Revolution service by the name of Ripley Copeland and he further saith that he believes that the said Ripley Copeland brought with him a discharge from the Regular service and that he is certain that he received a land warrant from the said Ripley Copeland and traded it to his own service.

State of South Carolina Chesterfield District

This day personally appeared Aron Copeland before me the subscribing Justice, who after being duly sworn on the Holy evangelist of Almighty God, saith that sometime in the forepart of the Revolutionary War, his Brother Ripley Copeland entered the Service of the United States as a Soldier, this deponent says he did not see him Enlist, but that after he had enlisted he returned home and informed his father this deponent and the rest of the family that he had Enlisted for the term of three years. This deponent further says that after the Officer who Enlisted him had remained in the Settlement for several weeks and had raised a number of other recruits he marched them off and that he saw the said Ripley Copeland marched off with them and was gone about three years as well as he recollects. This deponent also states that when the said Ripley Copeland returned home he recollects he showed his discharge to his father and Brothers and that he heard his father read the same.

South Carolina Sumter District: I Ripley Copeland of Sumter District in the State of South Carolina do hereby declare that I enlisted in the Continental line of the Army of the Revolution and continued in the service until its termination at which period I was a private in Captain Joshua Bowman's company in the 1st Regiment of the North Carolina line and I also declare that I afterwards received a certificate for the reward of \$80 to which I was entitled under a resolve of

Congress passed the 15th of May 1778 and I further declare that I was not on the 15th May 1828 on the pension list of the United States.

on this thirtieth day of October 1832 personally appeared before the Presiding Judge of the court of Common Pleas of South Carolina for the District of Sumter Ripley Copeland Senior a resident of Sumter District aged seventy-one years who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7 1832 – that he Enlisted in the Army of the United States in the year 1777 10th day March for three years and served in the Regiment the 9th till the next spring – then was transferred to the 1st Regiment of North Carolina Troops under Colonel Clark, he Enlisted under Captain Ramsey and was discharged on 15 March 1780 under Captain Bowman. This Deponent resided in Chatham County North Carolina when he enlisted. This Deponent says that he was in the Battle of Monmouth which took place 28 June 1778, also in Battle Stony Point on 15 July 1779 and engaged in other Skirmishes in the Jerseys: this Deponent further says he was discharged in Charleston South Carolina on 15 March 1780. The deponent further states that his discharge was signed by General Lincoln Colonel Clark & Captain Bowman. This Deponent hereby relinquishes every claim whatever to a pension or annuity except the present and he declares that his name is not on the Pension Roll of any agency in any State.

[p 7: On November 13, 1845 in Sumter District South Carolina Rachel Copeland, 83, applied for a widow's pension under the 1838 act stating that she is the widow of Ripley Copeland, a pensioner of the United States for his service in the revolution; that she married him in the month of March 1781 on the Sabbath after the battle of Guilford Court House; that her husband died June 6, 1843; that he enlisted in 1778 under Matthew Ramsay
