Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Disability, Wounded in his left foot by a cannon ball When and where disabled; June 28, 1778, Monmouth

Resident; County of Henrico. Monthly allowance; \$5.00 Arrearages; \$200.00

Remarks; Enlisted June 1777; on the rolls in 1780.

Evidence incomplete: 1<sup>st</sup> The deposition of freeholders prove his disability for the last 9 or 10 years only. 2<sup>nd</sup> No evidence why application was not made prior to the 11th December 1788

States, by which he has had his right foot and ankle so injured as to be almost useless.
