Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

I do hereby Certified that Andrew Kennady entered either the last of October or first November 1777 as a Soldier in Colonel Marshall's [Thomas Marshall's] Regiment of State Artillery for three years & served until the 16 August 1780 when he was killed or otherwise lost at the Battle of Camden.

Given under my hand this 3rd day of September 1787

I do Certify that Andrew Kennedy served as Soldier in the State Regiment of Artillery & served to his last day faithfully. Given under my hand this 3rd day of April 1787. S/ Peter Kemp, late Capt. S. Arty.

[From rejected pension records in the Library of Virginia]

We do hereby certify that Andrew Kennedy of Westmoreland County Virginia enlisted as a Soldier under the command of Captain John Mayzard [John Mazarett] in the Continental line in the year 1778 for a term of 3 years or to the end of the War, in which time he was killed in a Battle to South. Given under our hands this 27th day of August 1831
