## Pension application of Joseph Quinlan VAS109 Transcribed by Will Graves

Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

## [From bounty land records in the Library of Virginia]

Hanover County to wit

Samuel J Winston (aged 67 years) made oath before me a justice of the peace for said County that he remembers Doctor Joseph Quinln [sic], and knew him very well and that he came to live at Hanover Town after the Revolutionary War and that it was said and believed that he had served as a Surgeon in the United States Army until the end of the revolutionary war to what Regiment he belonged I do not know.

## Petition for bounty land

The heir of Joseph Quinlan Surgeon Continental L.

This claim was reported in printed list No. 2, as not proved by public records. The settled accounts of Doctor Quinlan prove that he was Surgeon in the Continental line, from October 1778 to June 6 1779 – the testimony of sundry witnesses proves that he probably was in Service to the end of the war.

I think the claim ought to be allowed; as the whole evidence furnishes strong presumptive proof of its justice. If your Excellency should allow it = it ought to be made for services to the end of the war.
