I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Report on the claim of the heir of Williamson, alias William, Pace, a soldier of the Continental line for bounty land for his services.

To the Governor Sir,

Williamson Pace was a soldier of the Continental line. His name is on the Army Register; and he received 200 acres of land in the name of William Pace.

The claimant has presented no proof of his claim. His ancestor has received all the bounty land to which he was entitled from Virginia.

The petition of George S Pace of the County of Middlesex & State of Virginia respectfully states, that he is the son of Williamson alias William Pace deceased, who was a soldier in the revolution – that his said father entered the service from the County of King & Queen, in which he resided, but your memorialist being at that time born an infant, cannot say in what company or Regiment he served, or under what officers – His said father never returned home from the service, but died with the smallpox in service as your memorialist has always heard & believes – His said father had only one other child the is Benjamin R Pace, who died in 1813.
