[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]


I do hereby Certify that Joseph Jolley – Inlisted in the Continental Army under Captain John Pleasants of the [indecipherable] Virginia Regiment in the month of January February one thousand Seven hundred & Seventy Six for the term of two years and that about the Expiration of his Term while at the northward – he then inlisted for during the war and believe he went to the South with the Army and there he died. I also went into the Army under Captain Pleasants – Given under my hand this tenth day of April 1810

Henrico County Court March 1786

Ordered that a Certificate issued in favor of Mary Ann Jolly widow of Joseph Jolly deceased late a Soldier in the first Virginia Regiment and who died in the Service of the United States – in Order to entitle her to the pension allowed by Law – And it is further ordered to be certified that the said Mary Ann Jolly is in very needy and distressed Circumstances and has 3 children to maintain & support

June 13, 1786 Ms. the Jolly is to be put on the pension List with £12 allowance per annum. S/ A. Blair, G. C.

Mary Ann Jolly widow of Joseph Jolly late a private of the first Virginia Regiment and who died in the Service of the United States is entitled to the Sum of Twelve Pounds yearly which allowance is to commence from the first day of January 1786. Given under my hand at Richmond this 13<sup>th</sup> day of June 1786

[p 7: receipt signed by Nathaniel Wilkinson on the half of Mary Jolley [sic] and dated June 20,

1787 and given to the sheriff of Henrico County Virginia.]

[Note: most of the documents in this file relate to the annual authorization, disbursement and receipt of the pension due the widow. On page 42, there is a finding by the Henrico County Court in November 1789 that the widow died in the month of November 1797. On page 43, that is a receipt dated March 3<sup>rd</sup> 1800 indicating that 5 pounds 17 shillings and 8 pence were paid to Francis Hyland representing the amount due her up to the time of her death.]
