Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 28th day of August 1784, in the name of Joel Jones, as a Soldier of Cavalry for £44.18.2, which Certificate appears to have been delivered to William Barnett and was given for services prior to the 1st January 1782.

Given under my hand, at the Auditor's Office, Richmond, this $1^{\rm st}$ day of March 1838.

I do Certify that Joel Jones enlisted in Colonel Baylor's Dragoons July 1st 1780 for the War.

I do hereby certify that I was raised in the neighborhood of Joel Jones and knew him from my infancy. That he entered the service in a troop of Cavalry either in Bland's [Theodorick Bland's] or Washington's [William Washington's] Corps in the war of the revolution the time he entered the service I do not recollect but am positive he served to the end of the war he having never returned home until after the war was ended. This I know because he lived in the immediate neighborhood with myself.

Your memorialist one of the heirs of Joel Jones humbly represent that he has always understood that his father entered in the service in a troop of cavalry in the war the revolution and served to

the end thereof as will more fully appear by the certificate of Major Samuel J Winston hereto annexed, your petitioner humbly asked that you will take the matter under consideration indirectly Register of the Land Office to issue a warrant to the heirs of said Jones for such quantity of land as you may in your wisdom think just & write.
